MOTION OF NCSEA TO INTERVENE

Pursuant to North Carolina Utilities Commission ("Commission") Rules R1-5, R1-7, and R1-19, the North Carolina Sustainable Energy Association ("NCSEA") hereby moves to intervene in the above-referenced docket. In support of this motion, NCSEA states as follows:

- 1. NCSEA is a non-profit corporation formed under the laws of North Carolina, with individual, business, and government members located across the State. NCSEA's mission is to promote a sustainable future through the use of renewable energy and energy efficiency programs. NCSEA seeks to achieve its objectives by advocating for public policies that encourage the responsible technological and market development of renewable energy and energy efficiency, including all aspects of demand side management, a smart grid, energy storage, and vehicle electrification.
- 2. NCSEA has frequently appeared before this Commission as an intervenor, including in dockets concerning Duke Energy Carolina, LLC's ("DEC") applications for cost recovery under North Carolina's Renewable Energy and Energy Efficiency Portfolio Standard ("REPS law"). - 3. The Commission's ruling in this docket will have broad implications for both NCSEA and its members. NCSEA was a chief proponent of the REPS law and has a direct and substantial interest in its implementation to assure that the policies and goals of the REPS law are achieved in a manner consistent with the legislative intent. Additionally, some of NCSEA's members participate in utility efficiency programs, generate renewable energy certificates used by DEC and others to meet their obligations under the REPS law, and/or complete energy efficiency projects eligible for REPS compliance; as such, these members have an interest in the REPS compliance efforts of electric power suppliers.
- 4. NCSEA's participation in this docket will bring critical insight, knowledge, and understanding to the proceeding.
