I am a customer of Carolina Water Service in the Kings Grant Subdivision in Raleigh, NC. I recently received a letter about a proposed increase in sewer rates. It appears that our service provider is asking for a 22.38% increase in rate charged. While I certainly understand the need for modest increases over the years to address equipment repairs & upgrades and such, I think a 22.38% increase is a bit steep.

I cannot ask my employer for a 22.38% increase. Again I understand modest periodic increases but I think 22.38% is too high. I would ask that you try to hold the line

on the amount of increase allowed in the rates charged by Carolina Water Service.

Most cost of living adjustments are 2.5% - 5.0% around here at the present time. I think this would be more in ~~the~~ line with an appropriate rate increase for water & sewer services. Again I am requesting that you please hold the line on rate increases allowed by Carolina Water Service. I appreciate you representing us consumers on this matter.
