AFFIDAVIT OF DEAN R. GEARHART

AFFIDAVIT OF DEAN R. GEARHART, MANAGER - RATES AND PLANNING AQUA NORTH CAROLINA, INC.

Dean R. Gearhart, Manager - Rates and Planning, Aqua North Carolina, Inc. ("Aqua" or "Company"), first being duly sworn, deposes and says:

- 1. On March 7, 2018, Aqua North Carolina, Inc. (Aqua or Company) filed an Application for a general rate increase in this docket seeking authority to increase and adjust its rates for water and sewer utility service in all of its service areas in North Carolina.
- 2. On September 17, 2018, Aqua and the Public Staff filed a Partial Settlement Agreement and Stipulation ("Stipulation") in this docket. Section III, Paragraph FF of the Stipulation provides as follows:

The Stipulating Parties have agreed to a methodology for calculating regulatory commission expense, also known as rate case expense, and will update the number in Settlement Exhibit 1, Line 33 for actual and estimated costs once supporting documentation is provided by the Company. Aqua seeks a three-year amortization period; the Public Staff supports five.

In its Proposed Order, which was filed in this docket on October 30,
Aqua included the following finding of fact regarding the Company's rate case expense:

Due to the particular circumstances of this proceeding, the reasonable and appropriate period for amortization of rate case expenses in this case is four (4) years, except for the Company's 2017 depreciation study which shall be amortized over five (5) years.

- 4. As required by the September 17, 2018 Stipulation, Aqua has provided the Public Staff with all required documentation of rate case expense incurred to date in conjunction with this proceeding. The documentation provided by the Company includes only one estimate for the costs of preparing and mailing Notices to Customers once the Commission issues its final order in this case. Otherwise, all costs submitted by Aqua for review by the Public Staff and for inclusion in the Company's cost of service in this proceeding are based on actual costs incurred to date.
- 5. Aqua requests that the Commission approve and include total rate case costs in this proceeding in the amount of \$818,397. Those costs are broken down into the following categories and applicable amounts:

6. Aqua requests that the Commission approve cost recovery of the Company's total rate case costs in the amount of \$818,397, with those costs being amortized as follows; i.e., the Company's 2017 depreciation study should be amortized over five years and the remainder of the Company's rate case costs should be amortized over four years. Thus, the annual amount for rate case costs which Aqua requests that the Commission include in rates in this proceeding is \$201,666.
