NOW COME Old North State Water Company, LLC (“ONSWC” or “Applicant”), and the Public Staff of the North Carolina Utilities Commission (“Public Staff”) (collectively “Movants”), through undersigned counsel, and respectfully move the North Carolina Utilities Commission (“Commission”) to cancel the public hearing scheduled for 1:30 p.m. on October 7, 2021, in the above-captioned proceeding. In support of this Motion the movants show:

1. The September 21, 2021, Commission Order Establishing Discovery Guidelines, Scheduling Hearings, and Requiring Customer Notice specified that public hearings would be held on October 7, 2021, starting at 1:30 p.m. and 6:30 p.m. via Webex. The Order also stated that members of the public who wanted to testify must register in advance by the close of business on October 1, 2021.
2. The Public Staff has determined that eight members of the public have registered, and all eight have indicated they will testify at the 6:30 p.m. hearing. There are no registrants for the 1:30 p.m. hearing.

3. Given the lack of public witnesses for the 1:30 p.m. hearing, cancellation of the public hearing scheduled for that time would serve administrative convenience by saving the parties and the Commission time, without depriving any members of the public of the opportunity to testify.

THEREFORE, the Applicant and the Public Staff respectfully move the Commission for an order cancelling the 1:30 p.m. session of public hearing on October 7, 2021, in this matter.
