UPDATE:

Purchased Waste Water Treatment expense has been updated to reflect the annualized expense that is expected to be realized by (a) Aqua North Carolina Sewer and (b) Fairways Utilities Sewer going forward.

An adjustment has-been made to reflect the impact of a July 2020 rate increase for the Johnston County Wastewater Treatment and Transmission Services charge for Neuse Colony in Aqua NC's Central area.

The Company has been informed of the following rate change effective July 1, 2020 – pending Johnston County Board of Commissioners approval.

See attached e-mail from Chandra Cox Farmer of Johnston County Dept. of Public Utilities.

The monthly charge is increasing from \$3.50 per 1,000 gallons (\$2.37 + \$1.13) to \$4.24 (\$3.00+\$1.24), which is a 21.1% increase. This 21.1% increase has been applied to the amount requested in the rate filing for an additional Item 18 adjustment amount of \$12,867.87.

The adjustments to reflect the current level of expense in these categories are supported by the following schedules attached:

 <u>Purchased Waste Water Treatment Expense – Johnston County Wastewater</u> <u>Treatment and Transmission Services-2020 Price Increase (ITEM 18-PRCH</u> <u>WWT</u>). This schedule is an update to Item 10 Exhibit B3-c-6 and applies the 21.1% rate increase – effective July 1, 2020 – to the \$60,861.57 requested in the rate filing. This results in an Item 18 adjustment amount of \$12,867.87. The service is for wastewater treatment and transmission services provided for Neuse Colony in the Aqua Sewer Central area.

The update detailed in the schedules above are necessary to reflect the appropriate amount of Purchased Waste Water Treatment expense the Company expects to incur during the first year that rates are in effect as a result of this application.

Although the Johnston County Utilities Department has not completed the budgeting process or discussed the details with our County Manager or Board of Commissioners, I wanted to give you a head's up that Public Utilities staff plans to recommend several bulk customer water and sewer rate adjustments for FY 20/21. These recommendations are consistent with a third party rate study update completed February 2019.

Therefore, I would expect the bulk rates related to Aqua to be adjusted as follows:
