I understand that Duke Energy will soon install a Smart Meter on my house. This is alarming news for me. Scientific research has shown clear evidence that Smart Meters damage our nervous, endocrine and immune systems...causing cancer and other serious health conditions. Others have posted to the Docket much of this very credible information. I won't repeat with this post, but I do hope it is considered. Duke Energy trains their personnel to tell us that "Smart Meters are as safe as baby monitors." This is not true. The Analog Meter is the only one guaranteed not to damage our health. I have offered to buy an Analog Meter for Duke Energy to install instead of the Smart Meter. They tell me that is not an option. There should ALWAYS be a option for us to protect ourselves from damage to our health. I'm told I can "opt out", and have the Smart Meter installed in the "radio off" mode. That is the only option Duke Energy is offering me, if I want to protect my health. In order to do that, I must pay \$150 initially and have \$11.75 added each month to my power bill. That sounds like extortion to me. I'm paying Duke Energy so they won't damage my health!!! Now, I understand that after a year, and a 30 day notice, Duke Energy can switch the "radio off" on my installed Smart Meter to "radio on". They take my money for a year so I can have my health protected, only to ultimately leave me with a fully functioning Smart Meter in the "radio on" mode, as well as with all the health risks it creates. I have a doctor's statement on his prescription pad stating that for health reasons, I must be protected from radio frequency emissions. Duke Energy now tells me this script must be notarized. This is overly burdensome to have redone. This requirement should be eliminated. Please do the following: 1) Provide an Analog Meter option to the Smart Meter, even if we have to buy it ourselves for Duke Energy to install. 2) Remove the language from the implementation plan that allows Duke Energy to end any "opt-out" status after the first year and turn the "radio off" mode of the installed Smart Meter to "radio on". 3) Remove any other language from the implementation plan that will allow Duke Energy to make other changes that could be detrimental to our health going forward. 4) If a doctor's note must be required, remove the need for a notary if the note is clearly on the doctor's prescription pad or stationary.
