

NOW COME Invenergy Wind Development LLC and Invenergy Solar Development LLC (collectively "Invenergy" or the "Petitioners"), by and through their undersigned attorney, and respectfully request that the North Carolina Utilities Commission (the "Commission") allow them to intervene in the above-referenced dockets, pursuant to N.C.G.S. § 62-72 and Rules R1-7 and R1-19 of the Rules and Regulations of the Commission, and to grant them leave to participate fully as parties in these dockets. In support of this Petition, Petitioners show the Commission the following:

1. Petitioners are both limited liability companies existing under the laws of the State of Delaware with their principal office located at One South Wacker Drive, Suite 1900, Chicago, IL 60606.

2. Invenergy Wind Development LLC is the largest independent wind power company in North America. Invenergy Wind Development LLC and its affiliates have a portfolio of 4,215 MWs in wind generation facilities. It has announced its intentions, through its affiliate, Pantego Wind Energy LLC, to develop a wind-powered electric generating facility of up to 80 MW in Beaufort County, North Carolina. A Certificate of Public Convenience and Necessity for this facility was issued by Order of the Commission in Docket EMP-61, Sub 0 on March 8, 2012. The Integrated Resource Plans and Renewable Energy and Energy Efficiency Portfolio Standard (“REPs”) Compliance Plans of the retail electric utilities in North Carolina will affect the market for wind energy resources in North Carolina in which Invenergy Wind Development LLC or its affiliates intend to participate, and the economics of which will affect this Petitioner’s capital investment decisions.

3. Invenergy Solar Development LLC is active in the solar photovoltaic (“PV”) market, and, together with its affiliates, has completed over 40 MW of PV projects elsewhere in North America. It selectively pursues solar projects in areas, such as in North Carolina, where already it is developing other projects. It has secured property rights for, and is in the process of evaluating the feasibility of, three separate solar PV electric generating facilities in North Carolina. The Integrated Resource Plans and REPs Compliance Plans of the retail electric utilities in North Carolina will affect the market for solar PV renewable energy resources in North Carolina in which Invenergy Solar Development LLC or its affiliates intend to participate, and the economics of which will affect this Petitioner’s capital investment decisions.

5. Petitioners participation in this docket will not delay the proceedings or unduly burden the process of deciding the issues in these dockets.


6. Petitioners agree to accept electronic service of all filings in these dockets.






