BY THE CHAIRMAN: Commission Rule R8-67(c)(3) requires each municipal electric supplier and electric membership corporation (EMC), or its utility compliance aggregator, to file a verified Renewable Energy and Energy Efficiency Portfolio Standard (REPS) compliance report on or before September 1 of each year.

On March 10, 2011, Duke Energy Carolinas, LLC (Duke), filed a 2010 REPS compliance report in Docket No. E-7, Sub 984, on behalf of itself and Blue Ridge EMC, the City of Concord, the Town of Dallas, the Town of Forest City, the City of Highlands, the City of Kings Mountain, and Rutherford EMC. The Commission approved Duke's 2010 REPS compliance report on August 23, 2011.

On June 3, 2011, Progress Energy Carolinas, Inc. (PEC), filed a 2010 REPS compliance report in Docket No. E-2, Sub 1000, on behalf of itself and the towns of Black Creek, Lucama, Sharpsburg, Stantonburg, and Waynesville. The Commission approved PEC's 2010 REPS compliance report on November 10, 2011.

On August 24, 2011, the North Carolina Electric Membership Corporation (NCEMC) and GreenCo Solutions, Inc. (GreenCo), filed a motion requesting a time extension, through September 19, 2011, for the filing of NCEMC's annual report and GreenCo's 2011 REPS compliance plan and 2010 REPS compliance report. The Commission granted the requested time extension on August 31, 2011.

On August 25, 2011, Dominion North Carolina Power (Dominion) filed a 2010 REPS compliance report in Docket No. E-22, Sub 462, on behalf of itself and the Town

of Windsor. The Commission approved Dominion's 2010 REPS compliance report on December 15, 2011.

On August 30, 2011, EnergyUnited filed its 2010 REPS compliance report.

On August 31, 2011, the Tennessee Valley Authority (TVA) filed a 2010 REPS compliance report on behalf of Blue Ridge Mountain EMC, Mountain Electric Cooperative, Murphy Electric Power Board, and Tri-State EMC.

On August 31, 2011, North Carolina Eastern Municipal Power Agency (NCEMPA) filed a 2010 REPS compliance report on behalf of the cities and towns of Apex, Ayden, Belhaven, Benson, Clayton, Edenton, Elizabeth City, Farmville, Fremont, Greenville, Hamilton, Hertford, Hobgood, Hookerton, Kinston, LaGrange, Laurinburg, Louisburg, Lumberton, Macclesfield, New Bern, Pikeville, Pinetops, Red Springs, Robersonville, Rocky Mount, Scotland Neck, Selma, Smithfield, Southport, Tarboro, Wake Forest, Walstonburg, Washington, and Wilson.

On August 31, 2011, North Carolina Municipal Power Agency Number 1 (NCMPA1) filed a 2010 REPS compliance report on behalf of the cities and towns of Albemarle, Bostic, Cherryville, Cornelius, Drexel, Gastonia, Granite Falls, High Point, Huntersville, Landis, Lexington, Lincolnton, Maiden, Monroe, Morganton, Newton, Pineville, Shelby, and Statesville.

On August 31, 2011, Winterville filed its 2010 REPS compliance report.

On September 1, 2011, the Public Works Commission of Fayetteville (Fayetteville) filed its 2010 REPS compliance report. Also on September 1, 2011, Halifax EMC filed its 2010 REPS compliance report on behalf of itself and the Town of Enfield.

On September 2, 2011, Oak City filed its 2010 REPS compliance report.

On September 19, 2011, GreenCo filed a 2010 REPS compliance report on behalf of Albemarle EMC, Broad River Electric Cooperative (EC), Brunswick EMC, Cape Hatteras EMC d/b/a Cape Hatteras Electric Cooperative, Carteret-Craven EMC d/b/a Carteret-Craven Electric Cooperative, Central EMC, Edgecombe-Martin County EMC, Four County EMC, French Broad EMC, Haywood EMC, Jones-Onslow EMC, Lumbee River EMC, Mecklenburg EC, Pee Dee EMC, Piedmont EMC, Pitt & Greene EMC, Randolph EMC, Roanoke EMC d/b/a Roanoke Electric Cooperative, South River EMC, Surry-Yadkin EMC, Tideland EMC, Tri-County EMC, Union EMC d/b/a Union Power Cooperative, and Wake EMC.

On September 20, 2011, the City of Fountain filed a letter stating that it was undertaking efforts to complete its REPS compliance plan and report no later than December 31, 2011. On October 25, 2011, the City of Fountain filed its 2010 REPS compliance report.

The 2010 REPS compliance reports filed by Oak City and Winterville were not verified. The Chairman, therefore, finds good cause to require Oak City and Winterville to verify their 2010 REPS compliance reports on or before March 15, 2012. In addition, the Chairman finds good cause to request that the Public Staff review the 2010 REPS compliance reports (and the related compliance sub-accounts in the North Carolina Renewable Energy Tracking System) filed by EnergyUnited, Fayetteville, Fountain, GreenCo, Halifax, NCEMPA, NCMPA1, Oak City, TVA and Winterville, and provide the Commission with comments on or before April 5, 2012. Other parties in this proceeding may also file comments on these 2010 REPS compliance reports, with such comments being due on or before April 5, 2012.


IT IS, THEREFORE, ORDERED as follows:

1. That Oak City and Winterville shall verify their 2010 REPS compliance reports on or before March 15, 2012; and
2. That the Public Staff is requested to review the 2010 REPS compliance reports listed above and submit comments to the Commission on or before April 5, 2012. Other parties to this proceeding may also file comments on the listed 2010 REPS compliance reports on or before April 5, 2012.
