NCSEA'S MOTION FOR 4-DAY EXTENSION OF FILING DEADLINE


Pursuant to North Carolina Utilities Commission ("Commission") Rules R1-5, and R1-7, the North Carolina Sustainable Energy Association ("NCSEA") hereby moves the Commission extend the filing deadline for briefs and/or proposed orders from Monday 16 December 2013 to Friday 20 December 2013. In support of this motion, NCSEA shows as follows:

1. The Commission's 15 November 2013 *Notice of Due Date for Briefs and/or Proposed Orders* directs the parties to file their briefs and/or proposed orders with the Commission by 16 December 2013.
2. The undersigned has been sick since 26 November 2013 and this sickness has negatively affected his ability to work on NCSEA's post-hearing brief. The undersigned is taking antibiotics but they have not yet restored his health. An extension of 4 days would greatly enhance the undersigned's ability to file a higher quality brief.
3. The undersigned does not believe that a 4-day extension will prejudice any party to this proceeding or materially delay issuance of a final order in this docket.
4. The undersigned has consulted with Duke Energy, Dominion, the Public Staff, the Renewable Energy Group, and Southern Alliance for Clean Energy. Each of

these parties has indicated it has no objection to the extension. NCSEA has notified the remaining parties and none has raised an objection.

WHEREFORE, for the reasons set forth above, NCSEA prays for an extension of the filing deadline for briefs and/or proposed orders from Monday 16 December 2013 to Friday 20 December 2013 and for such other and further relief as the Commission may deem just and proper.


