It has come to the Commission's attention that Ordering Paragraph No. 8 of the November 8 Order incorrectly identified the county where the Applicant is directed to publish notice and that the public notice was incorrectly captioned. The Chairman finds good cause to issue this Errata Order correcting those errors.

IT IS, THEREFORE, ORDERED that the Applicant shall publish the Public Notice attached hereto as Appendix A in a newspaper having general circulation in Edgecombe County once a week for four successive weeks beginning at least 30 days prior to Friday, December 21, 2018.

PUBLIC NOTICE

NOTICE IS HEREBY GIVEN that the North Carolina Utilities Commission has scheduled a public hearing to be held on Wednesday, January 9, 2018, at 7:00 p.m. at the Edgecombe County Courthouse, 301 St. Andrew Street, Tarboro, North Carolina. The purpose of the hearing is to receive public witness testimony regarding the application of Edgecombe Solar, LLC (Applicant). Public witness testimony will be received in accordance with Commission Rule R1-21(g).

On October 5, 2018, the Applicant filed an application pursuant to G.S. 62-110.1 and Commission Rule R8-63 for a certificate of public convenience and necessity (CPCN) to construct a 75-MW_{AC} solar photovoltaic (PV) electric generating facility in Edgecombe County, North Carolina. The Applicant also filed for registration of the facility as a new renewable energy facility.

In support of the application for a CPCN, the Applicant filed the direct testimony of Ryan Van Portfliet and Meghan Schultz, as well as several exhibits. In summary, construction of the 75-MW_{AC} solar PV facility is anticipated to begin in June 2019, with the expected commercial operation date being as early as January 1, 2020. The facility will include the solar arrays, inverters, a substation, and interconnection facilities. The location of the proposed facility is approximately 600 acres of land on the north side of US Highway 64 Alternate West, east of the intersection with April Lane, and west of the intersection with Alston Lane, near Kingsboro, in Edgecombe County, North Carolina. The facility will interconnect with the electric transmission system owned by Virginia Electric and Power Company, d/b/a, Dominion North Carolina Power. The expected service life of the facility is 30 or more years.

Specific information about the application for a CPCN may be obtained from the Office of the Chief Clerk, North Carolina Utilities Commission, Raleigh, North Carolina, where a copy of the application, exhibits and supporting testimony are available for review by the public, and on the Commission's website at www.ncuc.net.

The Public Staff is authorized by statute to represent consumers in proceedings before the Commission. Written statements to the Public Staff should include any information that the writers wish to be considered by the Public Staff in its investigation of the matter. Such statements should be addressed to Mr. Christopher J. Ayers, Executive Director, Public Staff, 4326 Mail Service Center, Raleigh, North Carolina 27699-4300.

The Attorney General is also authorized by statute to represent consumers in proceedings before the Commission. Statements to the Attorney General should be addressed to The Honorable Josh Stein, Attorney General, 9001 Mail Service Center, Raleigh, North Carolina, 27699-9001.

Written statements are not evidence unless persons appear at a public hearing and testify concerning the information contained in their written statements.

Any person desiring to intervene in the proceeding as a formal party of record should file a petition under North Carolina Utilities Commission Rules R1-5 and R1-19 on or before Monday, December 31, 2018. Such petitions should be filed with the Chief Clerk of the North Carolina Utilities Commission, 4325 Mail Service Center, Raleigh, North Carolina 27699-4300. The direct testimony and exhibits of expert witnesses to be presented by intervenors should also be filed with the Commission on or before Monday, December 31, 2018.

The Commission may cancel the public witness hearing if no substantial written complaints regarding the proposed facility are received by the Commission's Chief Clerk on or before December 31, 2018.
