DOCKETS**

**MOTION TO CONSOLIDATE DOCKET NOS. W-1300, SUB 55, W-1320, SUB 0,  
W-661, SUB 9, AND W-1320, SUB 2**

NOW COMES ONSWC - Chatham North, LLC ("ONSWC – Chatham North")  
and respectfully moves the North Carolina Utilities Commission ("the Commission") to  
consolidate the above-referenced dockets into a single proceeding. The dockets involve  
two Applications for Transfer of Public Utility Franchise and for Approval of Rates, and  
consolidation of the dockets will allow for the expeditious resolution of the applications.

In support of this Motion, ONSWC – Chatham North shows the Commission the  
following:

1. On March 14, 2019, in Docket Nos. W-1300, Sub 55, and W-1320, Sub 0, ONSWC – Chatham North filed an Application for Transfer of the Public Utility Franchise of Briar Chapel from Old North State Water Company, LLC to ONSWC – Chatham North. In the Application, ONSWC – Chatham North has not proposed changing the current wastewater rates, and has proposed increasing the connection fees from \$1,500 per REU to \$4,000 per REU.

2. On August 5, 2019, in Docket Nos. W-661, Sub 9, and W-1320, Sub 2, ONSWC – Chatham North filed an Application for Transfer of the Public Utility Franchise of Fitch Creations d/b/a Fearington Utilities to ONSWC – Chatham North. In the Application, ONSWC – Chatham North has not proposed changing the current wastewater rates or the connection fees.


3. Once the Briar Chapel franchise and the Fearington franchise are transferred to ONSWC – Chatham North, they will be part of a combined and consolidated wastewater system owned by ONSWC – Chatham North in Chatham County. Therefore, the matters in the dockets are substantially related.

4. Because the Commission's consideration of these applications involve common questions of law and fact, consolidation of the dockets would save the Commission valuable time and resources.

WHEREFORE, for the foregoing reasons, ONSWC - Chatham North respectfully requests that the Commission grant this Motion to Consolidate and issue an order consolidating the dockets.
