NOW COMES THE PUBLIC STAFF – North Carolina Utilities Commission (the "Public Staff"), by and through its Executive Director, Christopher J. Ayers, and submits its Motion for an Extension of Time and in support thereof, states as follows:

- 1. On August 11, 2020, Virginia Electric and Power Company d/b/a Dominion Energy North Carolina (DENC or Company) filed an Application for a Change in Fuel Component of Electric Rates.
- 2. The Commission entered an Order on September 14, 2020 requiring the Public Staff to file its testimony and exhibits on or before October 26, 2020.
- 3. On October 23, 2020, DENC filed a Petition for Waiver of Notice Requirements. This Petition states that errors in Company witness Beasley's testimony were recently discovered. The Public Staff and DENC have been working together to correct the errors.

- 4. Further, the Commission has directed the Public Staff to prepare latefiled exhibits in the Duke Energy Carolinas rate case. These late-filed exhibits are complex and time consuming to prepare.
- 5. Because of the recently discovered errors in DENC witness Beasley's testimony and the preparation of the late-filed exhibits, the Public Staff requests a one week extension, until November 2, 2020, to file its testimony and exhibits. A corresponding one week extension, until November 9, 2020, for DENC to file its rebuttal testimony is also requested. A proposed order is attached to this Motion.
- 6. The Public Staff has spoken with counsel for DENC and they do not object to a one week extension for the Public Staff to file its testimony and exhibits with a corresponding one week extension to file rebuttal testimony.
- 7. The Public Staff has also spoken with counsel for CIGFUR and they do not object to a one week extension for the Public Staff to file its testimony and exhibits with a corresponding one week extension to file rebuttal testimony.

WHEREFORE, the Public Staff prays:

- That the Commission grant the Public Staff's request for an extension of time to file its testimony and exhibits;
- 2. That the Commission extend the time for the Public Staff to file its testimony and exhibits until November 2, 2020;
- 3. That the Commission extend the time for DENC to file its rebuttal testimony and exhibits until November 9, 2020; and

4. For such other and further relief as the Commission may deem just and proper.

BY THE COMMISSION: On August 11, 2020, Virginia Electric and Power Company d/b/a Dominion Energy North Carolina (DENC or Company) filed an Application for a Change in Fuel Component of Electric Rates pursuant to G.S. 62-133.2 and NCRC R8-55. An Order was entered on September 14, 2020 directing the Public Staff to file its testimony and exhibits on or before October 26, 2020. On October 26, 2020, the Public Staff filed a Motion for Extension of Time, until November 2, 2020, to file its testimony and exhibits.
