NOW COMES Virginia Electric and Power Company, d/b/a Dominion Energy North Carolina (“DENC” or the “Company”), by and through counsel and in response to the Commission’s Order Scheduling Hearings and Requiring Public Notice dated May 30, 2019, requiring DENC to file a list of witnesses, the order of witnesses, and estimated time for cross-examination of the witnesses to be called at the hearing of this matter scheduled for September 23, 2019, and provides the Commission with said list and cross-examination estimates.
