Timbermill Wind, LLC's Application for a Certificate of Environmental Compatibility and Public Convenience and Necessity to Construct 6.0 Miles of Transmission Line in Chowan County, North Carolina

Dear Clerk Campbell:

On June 21, 2021, Timbermill Wind, LLC ("Timbermill") filed Application for a Certificate of Environmental Compatibility and Public Convenience and Necessity to Construct approximately 6.0 Miles of Transmission Line in Chowan County, North Carolina in the above referenced docket. Pursuant to N.C. Gen. Stat. § 62-102(c), Timbermill arranged for publication of the application summary in the Chowan Herald (the "Herald"), which has general circulation in Chowan County. Publication was set to begin on Thursday, July 1, 2021 and run for four consecutive weeks, ending on Thursday, July 22, 2021. Yesterday, we received a call from the Herald explaining that due to a failure in their newsroom, the legal notice did not appear in their physical newspaper on July 1, 2021. However, the notice did appear on the Herald's website¹, as well as in their e-Edition². Attached is an email from the Herald explaining why the notice did not appear in their physical paper. Timbermill has made arrangements with the Herald to have the notice run an extra week so that it will still appear in the physical paper four times. The new physical publication dates are July 8, July 15, July 22, and July 29, 2021. Publication will still be completed well in advance of the

intervention deadline set by statute, which is 100 days from the application filing, or September 29, 2021. We do not believe this physical publication delay will have an impact on the proposed schedule included in Timbermill's application.
