NOW COMES Duke Energy Carolinas, LLC (“DEC” or the “Company”), pursuant to Chapter 62 of the General Statutes of North Carolina and the Rules of the North Carolina Utilities Commission (the “Commission”), and hereby moves the Commission to allow the withdrawal of the application for approval of the Residential New Construction Program (the “RNC Program”) in this matter. In support of this motion, the Company shows as follows:

1. On September 21, 2017, the Company filed an application for approval of the RNC Program.
2. On October 23, 2017, the Public Staff filed comments in support of the RNC Program.
3. Following numerous discussions with natural gas utilities subject to the Commission’s jurisdiction aimed at resolving their concerns regarding potential unintended consequences of the program design, the Company has decided to withdraw the request for approval of the RNC Program at this time.

WHEREFORE, for the reasons set forth above, Duke Energy Carolinas, LLC respectfully requests that the Commission allow the Company to withdraw the RNC Program in this matter.
