MOTION FOR EXTENSION OF  
TIME TO FILE NOTICE OF  
APPEAL AND EXCEPTIONS

Virginia Electric and Power Company, d/b/a Dominion Energy North Carolina (“DENC” or the “Company”), through counsel and pursuant to Rule R1-7 of the Rules of Practice and Procedure of the North Carolina Utilities Commission (“Commission”), hereby moves the Commission for an extension of time in which to file a notice of appeal and exceptions to the Commission’s February 24, 2020 *Order Accepting Public Staff Stipulation in Part, Accepting CIGFUR Stipulation, Deciding Contested Issues, and Granting Partial Rate Increase* (“Order”). In support of this motion, DENC respectfully shows unto the Commission the following:

1. Pursuant to N.C. Gen. Stat. § 62-90(a), any party to a proceeding before the Commission may appeal from any final order or decision of the Commission within 30 days after the entry of such final order or decision, “or within such time thereafter as may be fixed by the Commission, not to exceed 30 additional days.”

2. Currently, the deadline for filing a notice of appeal from the Order is March 25, 2020. The Company is still considering its options as it works with the Public Staff to come to an agreed upon revenue requirement and proposed rates commensurate with the Commission's Order. Given the pending issues in this current rate case, the Company requests additional time to determine whether to appeal the Commission's Order, and requests an additional 30 days to and including April 24, 2020, to file a notice of appeal and exceptions.

3. All parties in this docket have been notified of the Company's request and no parties have responded with any objections to the requested extension.

WHEREFORE, Dominion Energy North Carolina respectfully requests that the Commission grant its motion for extension of time to file a notice of appeal and exceptions and allow an additional 30 days, up to and including Friday April 24, 2020, in which any party may file a notice of appeal and exceptions to the Commission's Order.
