A RESOLUTION OBJECTING TO THE PROPOSED CAROLINA WATER SERVICE RATE INCREASE

WHEREAS, The Board of Directors of the Bradfield Farms Homeowners Association, being elected to serve the Residents of this Community, are objecting to the Carolina Water Service rate increase, Docket W-354 Sub 350.

WHEREAS, Carolina Water Service is entitled to make a 8% plus business profit, however a Water Rate increase of 51.68% and a Sewer Rate of 22.73% increase for Bradfield Farms are unfair and unreasonable.

The Federal Tax Cuts and Jobs Act (Tax Act of 2017) will have an impact on this utility, a tax reduction of 13% and if anything, the savings should be passed on to all of its North Carolina customers.

WHEREAS, Carolina Water Service requested and received rate increases in 2010, 2012 and 2017. The 2017 approved increase was 54.58% for water and 55.87% increase for sewer. This increased the average yearly water sewer expenditure for Bradfield Farms Families over \$300. The 2018 rate increase is more than excessive.

WHEREAS, the Bradfield Farms Homeowners wishes to convey with sincere appreciation and thanks to the State of North Carolina Utilities Commission and Public Staff for all efforts to deny, or at least limit, the Carolina Water Service rate increase.

NOW, THEREFORE, BE IT RESOLVED that the Board of Directors of the Bradfield Farms Homeowners Association, representing Nine Hundred and Sixty-Seven (967) Households, Unanimously Approve this Resolution at our Regular Board Meeting.



Dear Mr. Drooz.

I am writing in regards to the recent letter I received stating that Carolina Water Service of North Carolina is requesting permission to raise rates for my subdivision, Bradfield Farms in Charlotte, NC from the North Carolina Utilities Commission. The docket number is W-354, Sub 360.

As a consumer, I find a second rate increase in as many years as inappropriate. Have you seen their proposal? If my estimates are correct, my monthly bill could rise upwards of over 40%. Currently, I am paying in the neighborhood of \$75.00 per month. As few as five years ago, I was paying on average of \$25-30 monthly. Please tell me what has happened in this short amount of time that can justify the rate increases that Carolina Water System has been charging its customers? I have done a little research on this company and it would appear that they have very unfavorable ratings from its customer base. I believe it would be in the best interest of the utilities commission to investigate this themselves before granting this company any further rate hikes. Unfortunately, utilities such as water have no competition and our only choice is Carolina Water Service, so, we are at their mercy. The Utilities Commission is our only defense against these unjustifiable rate hikes. They claim that these rate hikes are justified because of reasons A, B, and C. I believe that Carolina Water Service should provide in detail why they need increases in their Monthly Metered Rates, Water Utility and Sewer Utility Services and why their previous rate hike last year was not sufficient enough. I implore the commission to deny any further requests from Carolina Water Service to increase their rates at this time or in the near future without complete transparency of their budgetary expenditures and revenues. It seems all too common that companies such as this are granted these hikes year after year without a complete investigation as to whether their requests are justifiable or not. I know we have seen no improvements since their last rate hike. Customers are stuck with higher rates and no indications of improvements of service while profit margins seem to get larger and larger every year.

Accompanying this letter is a petition of residents of Bradfield Farms who also agree with my position on this matter. It would be much appreciated if the commission take these signatures into account when making their decision. I will also be sending a copy of this letter and the signatures from the petition to the Attorney General's Office.

RE: Carolina Water Service, Inc of North Carolina ("CWSNC") rate increase proposal for water and sewer utility service and service problems at The Yachtsman Townhome & Condominium Community(the "Community" / Queens Harbor.

Dear Honorable Josh Stern and Mr. David Drooz:

The purpose of this letter is to serve as the Community's written objection to the proposed CWSNC rate increase, currently before the North Carolina Utilities Commission, as well as testimony of on-going service problems.

To provide you with some background information, the Community has 100 townhomes, each between 1,400 and 1,700 square feet, and 31 condominiums, each between 1,200 and 1,400 square feet. Community residents have joint use of several facilities, which include a swimming pool, clubhouse, and tennis courts.

The Community's main concerns regarding the rate increase are as follows:

1. Excessively high water and sewer rates, which range from \$85.00 per month to \$200.00 or more per month and are significantly higher than our neighboring communities.

The NC Water and Wastewater Rates Dashboard (<u>www.sog.unc.edu</u>) August 2018 report compares monthly water and sewer bills per 5,000 gallons, from the following utilities:

Carolina Water Service	\$111.61
Charlotte Meck Water	\$60.66
Belmont Water	\$80.44
Two Rivers Utilities / Gastonia Water	\$61.09
Kings Mountain Water	\$57.42

- 2. Community members consistently receive excessively high (erroneous) bills, due to "incorrect meter reads" or "broken meters," for example: \$88 normal bill v. \$250 incorrect bill, \$150 normal bill v. \$569 incorrect bill. Also, there have been multiple ever-changing 3rd party vendors, manually reading our meters.
- 3. The Community had a rate increase July 2017. During that increase, base water increased \$22.40 to \$24.44, usage per 1,000 gallons increased \$6.40 to \$7.70, base sewer increased \$42.40 to \$48.97, and usage per 1,000 gallons increased \$2.90 to \$3.11. This represents a 11.6% water rate increase and 15% sewer rate increase.
- 4. The Community challenges CWSNC's billing practices regarding actual meter read verses billing residents on averages, for example, a homeowner occupying their home full-time will have the same monthly water bill as a homeowner not occupying their home for months.
- 5. For 10 days in May 2018, the CWSNC's two main water softener filters' motor broke. The below pictures of dishes in resident's dishwasher show the water quality or lack thereof experienced by the Community during the 10 days described above. Although the filters and motor were replaced, the Community received no billing relief whatsoever.



6. On 9/7/18, there was a water line break in our community and while some residents were called by CWSNC with a "Boil Water Alert", <u>many were not!</u> There were no updates on this issue throughout the weekend and many could not get through to them via phone. At a minimum, CWSNC should have put alert notices on all the community's doors, to alert our community of this potentially dangerous event.

In addition, the Community points out CWSNC's recent legal costs of nearly \$1Million due to unlawfully releasing poorly treated sewage into the lower Saluda River. Is the Community's high water rates and CWSNC's frequent requests for rate increases implemented to help recover litigation costs?

Finally, in addition to the excessive rates, increased rate proposal and service issues, the Community is also concerned with the hardness and quality of the water. Community homeowners are all afraid to drink and use the water without buying drinking water or using a house water filter and majority of residents invested in additional (expensive) water softeners, to help with the erosion of home appliances, foul smells, and home values.

The Community is aware that the water quality is a separate issue from the proposed rate increase, however, homeowners want to document their concern and dissatisfaction with CWSNC's water quality and service.

We thank you for your time and respectfully submit this written objection to CWSNC's current proposed rate increase. Please do not hesitate to reach out if you need additional information from the Community.
