Dear Chief Clerk:

Pursuant to R8-63(e)(4) and R8-66(h) of the North Carolina Utilities Commission ("Commission") Rules and Regulations, Oak Trail Solar, LLC ("Oak Trail") submits this letter to notify the Commission that the change of control described in the March 30, 2021 filing in the above-referenced docket occurred on March 31, 2021. Leeward Renewable Energy Development, LLC ("LRED") acquired 100% of the membership interests in FS Saguaro, LLC, the direct upstream owner of Oak Trail, through a Purchase and Sale Agreement with First Solar, Inc. LRED is a wholly owned subsidiary of Leeward Renewable Energy, LLC ("Leeward"). Leeward is now the indirect upstream owner of Oak Trail.

As a result of the change of control, Oak Trail provides amended versions of CPCN Application Exhibit 1 (Applicant Information) and its prefiled direct testimony to provide information on Leeward and its ownership of Oak Trail.

(ii) Oak Trail Solar, LLC ("Oak Trail") is a Delaware limited liability company with its principal place of business in Dallas, Texas. Oak Trail was formed February 25, 2020. Oak Trail has obtained authority from the North Carolina Secretary of State to conduct business in North Carolina. A true and correct copy of the Application for Certificate of Authority was included with the CPCN application filed on September 17, 2020 as Application Addendum 1. Oak Trail's principal participants and officers are Jason Allen (Chief Executive Officer), Andrew Flanagan (Chief Development Officer), Christopher Loehr (Chief Financial Officer), and Theodore Matula (Chief Legal Officer & Secretary).

Oak Trail is a wholly owned indirect subsidiary of Leeward Renewable Energy, LLC ("Leeward"). Leeward is a growth-oriented renewable energy company that owns and operates a portfolio of 22 wind and solar farms across nine states, totaling more than 2 GW of installed capacity. In addition, Leeward has approximately 14 GW of new wind, solar, and energy storage projects under development across the United States including an expansive development pipeline of solar projects across more than 20 states. On March 31, 2021, Leeward acquired approximately 10 GW of development-stage projects from First Solar, Inc., including Oak Trail. Leeward is a portfolio company of OMERS Infrastructure, a preeminent global infrastructure investor and investment arm of OMERS,

one of Canada's largest defined benefit pension plans with \$109 billion (Canadian) in net assets. Leeward is headquartered in Dallas, Texas, with development offices in Chicago, Illinois, Houston, Texas and San Francisco, California.
