Biennial Determination of Avoided Cost Rates for Electric Utility Purchases from Qualifying Facilities – 2014

JOINT MOTION BY DUKE ENERGY CAROLINAS AND DUKE ENERGY PROGRESS FOR AN EXTENSION OF TIME

NOW COME Duke Energy Progress, Inc. and Duke Energy Carolinas, LLC (collectively, the "Movants") and, pursuant to Commission Rule R1-7, respectfully move the North Carolina Utilities Commission (the "Commission") for an eleven (11) day extension of time for all parties to file reply comments in the above-captioned docket. In support of this motion, the Movants show the following:

1. The Commission issued its *Order Establishing Procedural Schedule and Scheduling Public Hearing* on January 8, 2015, wherein it established a deadline of June 8, 2015 for reply comments and a deadline of July 6, 2015 for proposed orders.

2. On April 8, 2015 the Public Staff of the North Carolina Utilities Commission ("Public Staff") filed a motion for an extension of time, which the Commission granted on April 15, 2015, establishing a deadline of July 13, 2015 for reply comments and a deadline of August 10, 2015 for proposed orders.

3. On May 21, 2015 the North Carolina Sustainable Energy Association filed a motion for an extension of time, which the Commission granted on May 29, 2015, establishing a deadline of July 27, 2015 for reply comments and a deadline of August 24, 2015 for proposed orders.

4. Due to the press of other business and the complexity of the proceeding, the Movants need additional time to finish their reply comments. Accordingly, the Movants respectfully request an eleven (11) day extension of time, from Monday, July 27, 2015 until Friday, August 7, 2015, for all parties to submit their filings to the Commission. The Companies are not seeking any extension of the time period for discovery, however.

5. If the Commission allows the Movants' request, the Movants further request that the Commission allow an eleven (11) day extension for the proposed orders. Currently the proposed orders are due August 24, 2015; an extension of eleven (11) days would change the deadline to September 4, 2015.

6. Counsel has contacted the parties to this proceeding about this request, and they have indicated that they do not object to this motion.

WHEREFORE, the Movants respectfully request that the Commission issue an order extending the time for filing reply comments from July 27, 2015 until August 7, 2015, and for filing proposed orders from August 24, 2015 to September 4, 2015, and such other relief as the Commission deems just and proper.
