WHEREFORE, DEP respectfully requests that the Commission enter an Order (1) excusing the appearances of Kendra A. Ward, Eric Grant, Kenneth D. Church, Kelvin Henderson and Joseph A. Miller, Jr. at the hearing scheduled in this proceeding for Tuesday, September 18, 2018 and (2) accept DEP's Application for Fuel Charge Adjustment and the pre-filed testimony and exhibits of Kendra A. Ward, Eric Grant, Kenneth D. Church, Kelvin Henderson and Joseph A. Miller, Jr. into the record of this proceeding without requiring their appearance.
