

Pursuant to North Carolina General Statutes (“N.C. Gen. Stat.”) § 84-4.1 and Rule R1-22 of the North Carolina Utilities Commission (the “Commission”) Rules of Practice and Procedure, Jack E. Jirak of Duke Energy Corporation respectfully requests the Commission to enter an order permitting him to practice *pro hac vice* before the Commission on behalf of Duke Energy Progress, LLC and Duke Energy Carolinas, LLC (“DEP and DEC” or the “Companies”) in the above-captioned matters. In support of this motion, Mr. Jirak alleges and shows the following.

1. The above-captioned matters are regulatory proceedings before the Commission, governed by North Carolina public utility law.
2. DEP and DEC are limited liability companies, duly organized and existing under the laws of the State of North Carolina, and are public utilities under the laws of North Carolina with operations subject to the jurisdiction of this Commission.
3. Mr. Jirak is an attorney in good standing, licensed to practice law in the State of Georgia, and he will appear on behalf of the Companies in the above-captioned proceedings.

5. Mr. Jirak will continue to represent the Companies in the above-captioned proceedings until the final determination thereof, unless permitted to withdraw sooner by order of the Commission.

Mr. Jirak has agreed to be subject to the orders and is amenable to the disciplinary action and civil jurisdiction of the General Court of Justice and the North Carolina State Bar in all respects as if he were a regularly admitted and licensed member of the Bar of North Carolina in good standing.

7. The Bar of Georgia, in which Mr. Jirak is regularly admitted to practice, grants permission to members of the Bar of North Carolina in good standing to practice *pro hac vice* under circumstances similar to those authorized by N.C. Gen. Stat. § 84-4.1.

8. Mr. Jirak, who is Associate General Counsel in Duke Energy's Raleigh, North Carolina office, is associated for purposes of appearing before the Commission with Lawrence B. Somers, Deputy General Counsel at Duke Energy Corporation and a resident of this State who is duly and legally permitted to practice in the General Court of Justice of North Carolina, upon whom service may be had in all matters connected with the legal proceedings, or any disciplinary matter, with the same effect as if personally made on Mr. Jirak.


9. Mr. Jirak has not been disciplined by any court or lawyer regulatory organization, nor has he had *pro hac vice* privileges revoked.


4. I will, unless permitted to withdraw sooner by order of the Commission, continue to represent the Companies in the above-captioned proceedings until the final determination thereof.




