BY THE CHAIR: On October 20, 2020, the Commission issued an Order Denying Motion for Return of CPRE Proposal Security in the above-captioned dockets, denying Stanly Solar, LLC's (Stanly) request that the Commission compel Duke Energy Progress, LLC (DEP), to return the \$1 million surety bond provided by Stanly as Proposal Security for its bid in Tranche 1 of the Competitive Procurement of Renewable Energy (CPRE) Program authorized by House Bill 589 (S.L. 2017-192).

On November 13, 2020, Stanly filed a Motion for Extension of Time pursuant to N.C. Gen. Stat. § 62-90(a) requesting that the Commission extend the time within which to file notice of appeal and exceptions to the Commission's Order Denying Motion for Return of CPRE Proposal Security from November 19, 2020, up to and including up to and including December 19, 2020. In support of its motion, Stanly states that the Commission's Order Denying Motion for Return of CPRE Proposal Security "impacts numerous issues of law, fact, and policy which are still under review by Stanly to determine whether they should be considered for an appeal. Stanly has diligently worked through the Order but anticipates needing additional time to adequately assess whether to file a Notice of Appeal and Exceptions." In addition, Stanly stated that all parties have been notified of the Company's request for an extension of time and that no party objections to the request.

ORDER GRANTING EXTENSION OF TIME TO FILE NOTICE OF APPEAL AND EXCEPTIONS Based on Stanly's motion and the record, the Chair finds good cause to grant the requested extension of time for all parties to this docket. The Chair further notes that December 19, 2020, is a Saturday, and pursuant to Commission Rule R1-27, Stanly is entitled up to Monday, December 21, 2020, to file a notice of appeal and exceptions to the Commission's Order Denying Motion for Return of CPRE Proposal Security.

IT IS THEREFORE, ORDERED that all parties to this docket shall be, and the same are hereby, granted an extension of time until Monday, December 21, 2020, within which to file a notice of appeal and exceptions to the Commission's Order Denying Motion for Return of CPRE Proposal Security.

IT IS, THEREFORE, SO ORDERED.
