

Pursuant to Rule 1-7 and Rule R1-19 of the Rules and Regulations of the North Carolina Utilities Commission, Nucor Steel-Hertford, a division of Nucor Corporation, hereby moves to intervene in the above-captioned proceeding. In support of its petition, Nucor states:

1. On August 30, 2013, Dominion North Carolina Power filed its Integrated Resource Plan for 2013.

2. Nucor is a corporation organized pursuant to the laws of the State of Delaware with its corporate headquarters located at 2100 Rexford Road, Charlotte, North Carolina 28211.

3. Nucor owns and operates a steel recycling facility located in Hertford County, North Carolina, which produces steel plate. Virginia Electric and Power Company does business in North Carolina as Dominion North Carolina Power (hereinafter "DNCP"). Nucor is a customer of DNCP and takes service pursuant to a special contract for electric service, as amended, subject to the jurisdiction of the North Carolina Utilities Commission.

4. As a current customer of DNCP, Nucor has an interest that is directly affected by the outcome of this proceeding, and, in accordance with the Commission's

Rule R1-19, has a right to intervene in this proceeding.

5. Nucor's interest is not adequately represented by any other party, and Nucor should not be consolidated with any party or group of parties.

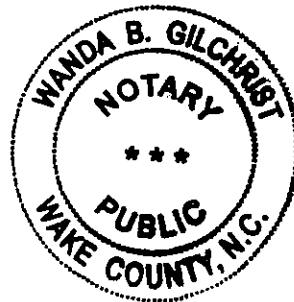


