C. <u>COMMUNICATIONS</u>

P1. DOCKET NOS. P-100, SUBS 133I AND 133n, AND P-100, SUB 171 – CERTIFICATION OF ELIGIBLE TELECOMMUNICATIONS CARRIERS TO CONTINUE TO RECEIVE FEDERAL UNIVERSAL SERVICE HIGH-COST SUPPORT

EXPLANATION: In order to receive Federal Universal Service High-Cost Support for the calendar year 2019, a state is required pursuant to Section 54.314(a) of the rules of the Federal Communications Commission (FCC) to file an annual certification with the FCC and the Universal Service Administrative Company (USAC). The certification must state that all federal high-cost support provided to carriers within that state was used in the preceding calendar year and will be used in the coming calendar year only for the provision, maintenance, and upgrading of facilities and services for which the support is intended. Absent such certification, eligible companies will not receive federal high-cost support for the calendar year 2019. For a carrier to receive support throughout the succeeding calendar year, the certification from the state must be received on or before October 1. In order to make this certification to the FCC and USAC, eligible high-cost regulated telephone companies in North Carolina must submit to the Commission a sworn affidavit written in the manner required by 54.314(a).

The Commission has received affidavits from 17 eligible telecommunications carriers: Barnardsville Telephone Company, BellSouth Telecommunications, LLC, Carolina Telephone & Telegraph Company, Central Telephone Company, Citizens Telephone Company, Ellerbe Telephone Company, Frontier Communications of the Carolinas, LLC, Mebtel, Inc., North State Telephone Company, Pineville Telephone Company, Saluda Mountain Telephone Company, Service Telephone Company, Windstream Concord Telephone LLC, Windstream Lexcom Communications, LLC, Windstream North Carolina, LLC, Verizon South Inc., and Wilkes Communications, Inc. RECOMMENDATION: (Proffitt) That based on the filed information, the Commission send appropriate letters to the FCC and USAC certifying that the 17 high-cost telephone companies in North Carolina are in compliance with Section 254(e) of the Telecommunications Act of 1996 and are eligible to receive federal high-cost support for the year 2019.

D. <u>ELECTRIC</u>

P1. <u>APPLICATION FOR CERTIFICATE OF PUBLIC CONVENIENCE AND</u> <u>NECESSITY TO CONSTRUCT SOLAR FACILITY</u>

EXPLANATION: The following application seeking a certificate of public convenience and necessity pursuant to N.C. Gen. Stat. § 62-110.1 for construction of a solar photovoltaic electric generating facility was filed pursuant to Commission Rule R8-64.

Dominion Energy North Carolina:

 <u>Docket No. SP-8498, Sub 0</u> – Application of Hawtree Creek Farm Solar, LLC, for a Certificate of Public Convenience and Necessity to Construct a 65-MW Solar Photovoltaic Facility in Warren County, North Carolina

The Public Staff has reviewed the application and determined that it complies with the requirements of N.C. Gen. Stat. § 62-110.1 and Commission Rule R8-64.

The applicant also filed a registration statement for a new renewable energy facility pursuant to Commission Rule R8-66(b). The registration statement included a certified attestation that: (1) the facility is in substantial compliance with all federal and state laws, regulations, and rules for the protection of the environment and conservation of natural resources; (2) the facility will be operated as a new renewable energy facility; (3) the applicant will not remarket or otherwise resell any renewable energy certificates sold to an electric power supplier to comply with N.C. Gen. Stat. § 62-110.1; and (4) the applicant will consent to the auditing of books and records by the Public Staff insofar as those records relate to transactions with North Carolina electric power suppliers.

RECOMMENDATION: (T. Williamson) That the Commission issue an order approving the application issuing the requested certificate for the facility, and accepting the registration statement for this facility. A proposed order has been provided to the Commission Staff.

E. <u>WATER</u>

P1. <u>DOCKET NO. W-1079, SUB 17 – CHRISTMOUNT CHRISTIAN ASSEMBLY, INC.</u> <u>– REQUEST FOR TARIFF REVISION</u>

EXPLANATION: On August 17, 2018, Christmount Christian Assembly, Inc. (Applicant), filed a letter with the Commission seeking authority to amend its tariff for the purpose of passing along to its customers in Christmount Christian Assembly and Christmount Subdivision in Buncombe County, North Carolina, the increased cost of purchasing sewer service from the Metropolitan Sewerage District of Buncombe County (MSD). MSD's new rates went into effect July 1, 2018. On August 30, 2018, the Applicant filed a verification pursuant to N.C. Gen. Stat. § 62-133.11.

The Applicant serves approximately 102 metered water and sewer connections, including approximately 88 privately-owned residences and 14 non-residential properties used for camp and conference activities.

The Public Staff has reviewed the Applicant's request and recommends that the Applicant be allowed to increase its sewer rates as shown below:

Under the new rates, the average residential monthly sewer bill will increase from \$41.58 to \$42.35, based on an average consumption of 4,500 gallons.

P2. <u>DOCKET NO. W-1148, SUB 16 – MOUNTAIN AIR UTILITIES CORPORATION –</u> <u>REQUEST FOR TARIFF REVISION</u>

EXPLANATION: On July 26, 2018, Mountain Air Utilities Corporation (Mountain Air), filed a petition pursuant to N.C. Gen. Stat. § 62-133.11, requesting authority to amend its tariff for the purpose of passing along to sewer customers in its Mountain Air Development in Yancey County an increase in the cost of purchasing sewer service from the Town of Burnsville (Burnsville). N.C. Gen. Stat. § 62-133.11(a) provides that the Commission shall allow a water or sewer utility to adjust its rates approved pursuant to N.C. Gen. Stat. § 62-133 to reflect changes in its costs based solely on changes in the rates imposed by third-party suppliers of purchased water or sewer service. Mountain Air serves approximately 424 residential and 25 commercial sewer customers.

The Public Staff has reviewed the current rates and recommends that Mountain Air be allowed to increase both its residential sewer flat rate and commercial sewer base charge by \$1.20 per month for the increased cost of purchasing sewer treatment from Burnsville. The present and proposed rates are as follows:

ORDER APPROVING TARIFF REVISION AND REQUIRING CUSTOMER NOTICE

BY THE COMMISSION: On August 17, 2018, Christmount Christian Assembly, Inc. (Applicant), filed a letter with the Commission seeking authority to amend its tariff for the purpose of passing along to its customers in Christmount Christian Assembly and Christmount Subdivision in Buncombe County, North Carolina, the increased cost of purchasing sewer service from the Metropolitan Sewerage District of Buncombe County (MSD). MSD's new rates went into effect July 1, 2018. On August 30, 2018, the Applicant filed a verification pursuant to N.C. Gen. Stat. § 62-133.11. The Applicant serves approximately 102 metered water and sewer connections, including approximately 88 privately-owned residences and 14 non-residential properties used for camp and conference activities.

The Public Staff has reviewed the Applicant's request and recommends that the Applicant be allowed to increase its sewer rates as shown below:

Under the new rates, the average residential monthly sewer bill will increase from \$41.58 to \$42.35, based on an average consumption of 4,500 gallons.

Based upon the foregoing, the Commission is of the opinion that the Applicant should be allowed to increase its sewer usage rate by \$0.17 per 1,000 gallons.

^{3/} This special assessment to residents currently being served by the Company, lot owners, and Christmount Christian Assembly (Christmount), was approved by the Commission by order dated May 19, 2009, in Docket No. W-1079, Sub 10, to provide for the repair and replacement of the failing water distribution and wastewater collection systems.

The Company is authorized to collect the special assessment for a period of 81 months, from June 2009 through February 2016. Current residential customers, lot owners, and Christmount may elect to prepay their assessments in a lump sum for the period elected and, in return for the lump sum prepayment, receive a discount, consistent with the methodology set forth in paragraph 21 of the Company's Revised Petition filed on March 18, 2009, in Docket No. W-1079, Sub 10. For example, customers with a 5/8 inch meter may prepay the assessment for one year for a discount of 1.5%, resulting in an annual prepaid amount of \$354.60 (\$30 times 12 months times 98.5%).

The Company is authorized to disconnect any existing residential customer that fails to pay the assessment authorized by the Commission, and is likewise authorized to refuse to connect any of the unbuilt lots to the Company's water and sewer system, unless the authorized assessments associated with such residences or unbuilt lots, and all accrued finance charges assessed pursuant to Commission Rule R12-9, have been paid.
