Thank you for your August 7, 2020, letter transmitting the revised archaeological report for the project noted above. We have reviewed this report and offer the following comments.

The revised report contains information regarding artifact analysis and curation, as well as clarification regarding Figure 4.3-13. This final report is consistent with Office of State Archaeology (OSA) Standards and Guidelines and will be incorporated into the OSA site file library.

We note that the artifacts collected during the survey will not be curated because "all but one owner has requested that the artifacts be returned to them" (page 4-5). Given that the landowners did not permit artifact curation, we request the following be submitted to the OSA through this office:

- Original image files of all temporally diagnostic artifacts, in native file format and size, organized by site number
- Original field notes for all sites, or scans at a resolution no less than 400 dpi, organized by site number

Please submit this information on CD-R or DVD-R disks, with CD-R Archival Gold or DVD-R Archival Gold disks preferred. Disks should be labeled directly using either CD-safe markers or a laser-printer, with laser-printing preferred. Adhesive labels should not be placed on CDs. Disks should be labeled with the following information: name of the submitting party, the environmental review number, range of site numbers to which the associated data pertain, and the date data was transferred to CD (month/year). Discs should be stored in acid-free paper sleeves labeled with the same information written or printed on the CD.

The above comments are made pursuant to Section 106 of the National Historic Preservation Act and the Advisory Council on Historic Preservation's Regulations for Compliance with Section 106 codified at 36 CFR Part 800.
