Virginia Electric and Power Company, d/b/a Dominion Energy North Carolina (“DENC” or the “Company”), through counsel and pursuant to Rule R1-7 of the Rules of Practice and Procedure of the North Carolina Utilities Commission (“Commission”) hereby moves the Commission for admission of Jason E. Williams’ rebuttal testimony exhibits into evidence and the record in this proceeding. In support of this motion, DENC respectfully shows unto the Commission the following:

1. On September 12, 2019, pursuant to the Commission’s May 30, 2019 *Order Scheduling Investigation and Hearings, Establishing Intervention and Testimony Due Dates and Discovery Guidelines and Requiring Public Notice* and the Commission’s September 11, 2019 *Order Granting Extension of Time*, DENC submitted for filing in this proceeding the Rebuttal Testimony and Exhibits of Jason E. Williams.

2. On September 25, 2019, Jason E. Williams appeared before the Commission to sponsor his rebuttal testimony that was filed on September 12, 2019. DENC counsel moved to have Mr. Williams' pre-filed rebuttal testimony and exhibits entered into evidence. The exhibits were identified as pre-marked Company Rebuttal Exhibit JEW-1 through Company Rebuttal Exhibit JEW-8. Chair Mitchell granted DENC's motion with respect to Mr. Williams' pre-filed rebuttal testimony, but deferred ruling on the admission of Mr. Williams' rebuttal exhibits until the close of his in-person testimony.

3. Mr. Williams' live testimony concluded on the afternoon of September 25, 2019. Counsel for DENC inadvertently failed to renew its motion to admit the exhibits to Mr. Williams' pre-filed rebuttal testimony at the close of his in-person testimony.

4. Admission of the exhibits to Mr. Williams' pre-filed rebuttal testimony at this time will not prejudice the intervenors to this proceeding.

WHEREFORE, DENC respectfully requests that the Commission grant its motion to admit Jason E. Williams' rebuttal testimony exhibits into evidence and the record in this proceeding.
