Re: Implementation by the North Carolina Utilities Commission (the Commission) of Executive Order Nos. 142 and 124

Dear Governor Cooper:

This report covers activities related to EO 142 for the period beginning July 1, 2020 through the expiration of EO 142 on July 29, 2020 and concluding on July 31, 2020 (the Reporting Period). This report is the fourth for which the reporting period spans one month and builds upon the data collected for reports submitted on April 13, 20, and 27, May 4 and 15, June 19, and July 15. This report includes information provided by 307 Utility Service Providers,¹ more than half of all Utility Service Providers in North Carolina. Most of the state's large and mid-sized providers submitted reports and most of the providers that did not report serve smaller numbers of customers.

On May 12, 2020, the Attorney General's Office granted a waiver of the reporting requirements for five "foreign" electric membership corporations.² These EMCs are headquartered outside of North Carolina, and their billing systems do not allow them to track North Carolina customers separately from their other customers. In requesting the waiver, these five EMCs committed to continue to abide by the requirements of EO 124 for disconnects, penalties, and repayments.

Of the 307 Utility Service Providers that reported, 67 are electricity providers, seven are natural gas providers, and 233 are providers of water and/or wastewater services. Additionally, of those 307 Utility Service Providers that reported, 230 are governmental or quasi-governmental entities, 35 are investor-owned, and 42 are member-owned.

Residential Accounts³

The Utility Service Providers report that 438,381⁴ residential customer accounts became eligible for disconnection due to non-payment but were not disconnected during the Reporting Period, compared with 490,845 accounts reported in June.

The Utility Service Providers report that 27,272 extended repayment plans were established for residential customers during the Reporting Period, more than double the 13,172 that were reported in June. Between April 1 and July 31, a total of 70,574 extended repayment plans were reported as being established by Utility Service Providers.

Additionally, Utility Service Providers report reconnecting 2,199 residential customers during the Reporting Period, compared to 1,024 in June. Between April 1 and July 31, a total of 5,168 customers have been reported as being reconnected.

Finally, \$10,211,981 in late fees and penalties were reported as not charged to residential customers during the Reporting Period. Between April 1 and July 31, Utility Service Providers have reported not charging residential customers \$41,506,489 in late fees and penalties.

Non-Residential Accounts

The Utility Service Providers reported that 25,865⁴ non-residential customer accounts became eligible for disconnection due to non-payment but were not disconnected during the Reporting Period, compared to 28,700 reported in June.

The Utility Service Providers report that 786 extended repayment plans were established for non-residential customers during the Reporting Period, up from 305 in June and leading to a total of 1,992 in total since April 1.

Additionally, 121 non-residential customers were reported as being reconnected during the Reporting Period, compared to 102 in June for a total of 301 reconnections between April 1 and July 31.

Finally, \$1,395,041 in late fees and penalties were reported as not charged to non-residential customers during the Reporting Period and contributing to \$5,406,026 in total between April 1 and July 31.

Utility Arrearage

With the transition to the monthly reporting obligation, the Commission requested that the Utility Service Providers provide information regarding their arrearages and past due accounts in order to shed additional light on the financial impact of the COVID-19 crisis. As this information was not specifically requested in EO 124 or 142, the Commission did not require Utility Service

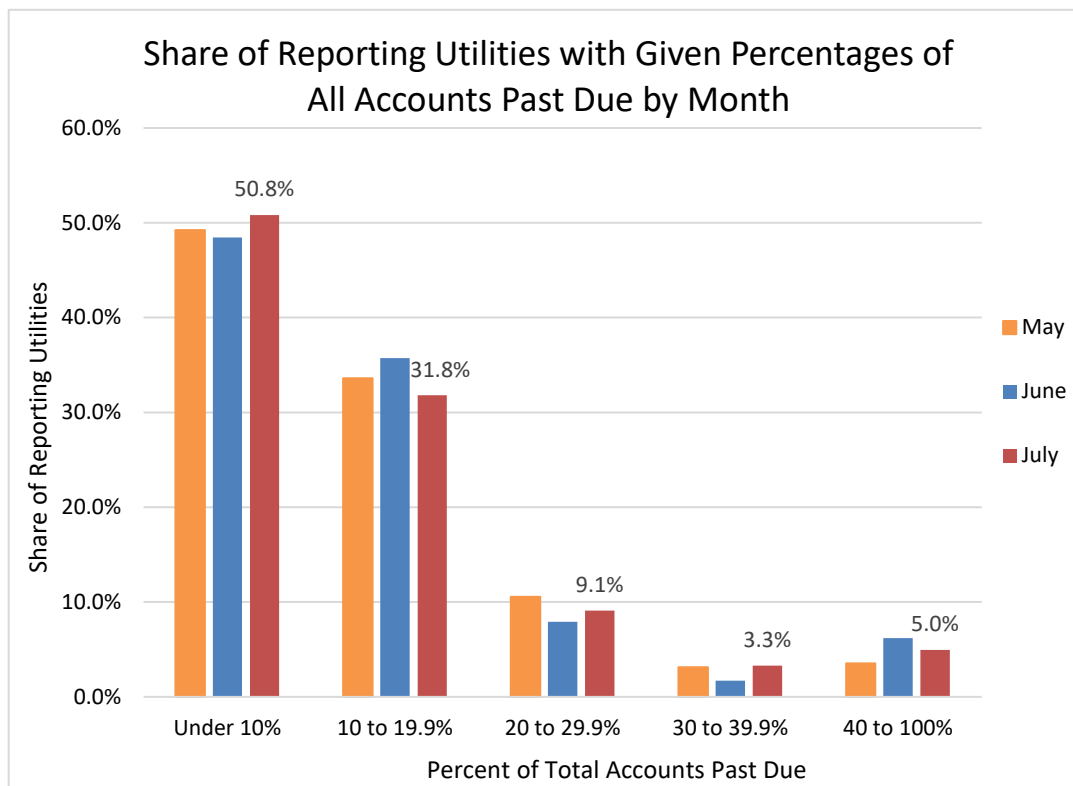
⁴ The Commission notes that Utility Service Providers might be misinterpreting this question; some might be providing the total number of accounts currently eligible for disconnection instead of the number of accounts that became eligible for disconnection during the Reporting Period. It is also important to note that individual households could be counted two or even three times in this figure if their electricity, natural gas and water accounts were all eligible for disconnection.

Providers to respond; however, but 245 out of the 307 respondents for the Reporting Period did provide this information.

The Utility Service Providers that responded report 1,092,262 residential and non-residential accounts past due, carrying an aggregate amount of \$273,145,950 in customer arrearages. Total reported arrearages increased \$15,296,410 over last month despite there being 52 fewer utilities reporting this data for this Reporting Period. Of this reported amount, approximately 65% is attributable to the three largest investor-owned electric utilities - Duke Energy Carolinas, Duke Energy Progress, and Dominion Energy.

The average percentage of customers with past due accounts for the 242 Utility Service Providers that responded is 14.6%, up from an average of 13.9% in June across 291 Utility Service Providers who reported. Forty-two utilities reported that at least 20% of their customer accounts were past due on July 31 and 12 utilities reported that more than 40% of their customer accounts were past due. A summary of the distribution of total accounts past due for May, June, and July is provided in Figure 1.

- Notice posted at utility office or on door of Town Hall
- Posted Executive Order text and brief description on the Town's website
- Posting on Town's website and on Facebook
- Radio interview with local radio station; press release
- Notification on customer bills and through other mailings
