MOTION TO INTERVENE

Pursuant to North Carolina Utilities Commission ("Commission") Rules R1-5, R1-7 and R1-19, the North Carolina Pork Council (the "Pork Council" or "Council") hereby moves to intervene in the above referenced docket. In support of its motion, the Pork Council states as follows:

- 1. The Pork Council is a non-profit organization with its principle place of business in Raleigh, North Carolina. The Council's primary mission is to develop and promote a socially responsible and profitable pork industry in the State. The Pork Council seeks to achieve these objectives through education and research, and by advancing sound public policy in areas of concern.
- 2. The Pork Council represents the interests of more than 46,000 North Carolina citizens who work full-time in the pork industries. Agriculture is North Carolina's largest industry and pork production is the second largest sector in that industry. North Carolina's pork industry also ranks second in the United States. At the same time, over 80 percent of North Carolina's hog farms are owned and operated by individual farm families. Many of these farms have been passed on from generation to generation and over time these operations have contribute significantly to the quality of life in their respective communities forming a vital part

of North Carolina's economy and way of life. The Pork Council provides meaningful leadership in this very important and dynamic industry.

- 3. In this the docket, the North Carolina Utilities Commission ("Commission") has started the process to implement certain parts of recently enacted S.L. 2017-192, an act that overhauls North Carolina's renewable energy initiative. Specifically, new G.S. & 62-110.8 mandates the use of a competitive bidding process to attain certain renewable energy goals. The rules implementing this process will influence the development of renewable energy in North Carolina for years to come.
- theoretical, is now a reality and on the cusp of becoming a key component of raising hogs in North Carolina. Indeed, many leading waste management technologies adopted by North Carolina's hog producers capture methane that in turn is used in a variety of ways to produce energy, from the on-farm generation of electricity to the large-scale distribution and use as a substitute or alternative to fossil-derived natural gas in multiple applications. The rules being considered in this docket will directly impact these activities. For that and other reason, the Pork Council and its constituents have a direct, vested interest in this proceeding.
