NOW COMES the North Carolina Attorney General's Office (AGO) and requests that the Commission issue an order extending the filing deadlines in the above-captioned docket. In support of this motion, the AGO shows the following:

- 1. On May 1, 2020, in Docket No. E-100, Sub 165, Virginia Electric and Power Company d/b/a Dominion Energy North Carolina (DENC) filed its 2020 Integrated Resource Plan (IRP) pursuant to N.C. Gen. Stat. §§ 62-2 and 62-110.1 and Commission Rule R8-60 contemporaneously with the filing of its 2020 IRP Plan in its Virginia jurisdiction, pursuant to Va. Code § 56-599.
- 2. On September 1, 2020, Duke Energy Carolinas, LLC (DEC), and Duke Energy Progress, LLC (DEP, and together with DEC, Duke) filed their 2020 Integrated Resource Plans (Duke 2020 IRPs), 2020 Renewable Energy and Energy Efficiency Portfolio Standard (REPS) Compliance Plans, and Competitive Procurement of Renewable Energy Compliance (CPRE) Compliance Plans.
- 3. Pursuant to Commission Rule R8-60(k), Intervenors may file evaluations, alternative plans, or reports on the utility plans within 150 days after September 1 or the filing of the utility plans. Additionally, within 60 days after the filing of initial comments, the parties may file reply comments.

- 4. On January 8, 2021, on request of the Public Staff-North Carolina Utilities Commission, the Commission extended the date for parties to file initial comments to February 26, 2021, and extended the date for parties to file reply comments to April 27, 2021.
- 5. The AGO has run into some editing and technical problems with the documents that make up AGO's comments in the IRP docket and requests that the Commission extend the current deadline for initial comments one business day until Monday, March 1, 2021 for parties to file their initial comments, and extend the deadline for reply comments a commensurate number of days from April 27, 2021 to April 30, 2021.
- 6. The undersigned has communicated with counsel for DEC, DEP, DENC, Public Staff-North Carolina Utilities Commission, CUCA, ElectriCities, Broad River, CIGFUR, CCEBA, NRDC, SACE, Sierra Club, Buncombe County, NCSEA, Tech Customers, NC WARN, and CBD who stated that they do not object to requested extensions. Further, no other Intervenors have responded with any objections to the request.

Wherefore, the Attorney General's Office respectfully requests an extension of one business day, up to and including Monday March 1, 2021, in which to file initial comments in this matter and an extension of the deadline for reply comments from April 27, 2021, up to and including Friday, April 30, 2021.
