NOW COMES THE PUBLIC STAFF – North Carolina Utilities Commission (Public Staff), by and through its Executive Director, Christopher J. Ayers, and moves the North Carolina Utilities Commission (Commission) to extend the time to file the Public Staff's joint testimony and exhibits of Michael C. Maness and Michelle M. Boswell to Tuesday, December 22, 2020 subject to the condition described below. In support thereof, the Public Staff respectfully shows the Commission the following:

1. On October 26, 2020, Duke Energy Carolinas, LLC (DEC), and Duke Energy Progress, LLC (DEP, together Duke or the Companies) filed a Joint Petition for Financing Orders pursuant to N.C. Gen. Stat. § 62-172 (Joint Petition), seeking authority from the Commission to finance the storm recovery costs of the respective Companies due to Hurricanes Florence, Michael, and Dorian, and Winter Storm Diego.

- On November 6, 2020, the Commission issued its Order Scheduling Hearing, Requiring Filing of Testimony, and Establishing Discovery Guidelines (Order).
- 3. The Order provides "[t]hat direct testimony and exhibits of the Public Staff and other intervenors shall be filed on or before December 21, 2020 and that the rebuttal testimony of DEC and DEP, if any, shall be filed on or before January 11, 2021."
- 4. The Public Staff has worked diligently to meet the current December 21, 2020, deadline for the filing of its testimony. In fact, the Public Staff has already filed the testimony of six of its witnesses, and plans to file additional testimony before the close of business. However, Public Staff witness Maness has been suffering from a medical issue that has prevented the Public Staff from finalizing his and Ms. Boswell's joint testimony. Consequently, the Public Staff is in need of an additional day, solely to file the joint testimony and exhibits of Maness and Boswell.
- 5. Based on the foregoing, the Public Staff requests an extension of time to Tuesday, December 22, 2020, to file the joint testimony and exhibits of Public Staff witnesses Maness and Boswell, and a corresponding extension to January 12, 2020, should be granted for the Companies to file its rebuttal testimony, solely as to the joint testimony and exhibits of Public Staff witnesses Maness and Boswell.

6. The undersigned counsel for the Public Staff has contacted counsel

for the Companies and is authorized to represent that the Companies do not object

to the extension requested by the Public Staff, provided the Commission grants a

corresponding extension for Companies to file the rebuttal testimony of its

witnesses as to the joint testimony and exhibits of Public Staff witnesses Maness

and Boswell.

WHEREFORE, the Public Staff requests that the Commission enter an

order (1) granting an extension until Tuesday, December 22, 2020, for the Public

Staff to file the joint testimony and exhibits of Michael C. Maness and Michelle M.

Boswell, and (2) granting an equivalent one-day extension to January 12, 2021 for

the Companies to file its rebuttal testimony and exhibits as to the joint testimony

and exhibits of Public Staff witnesses Maness and Boswell.
