from the 4th quarter of 2017 (“2017 Q4”) through the 3rd quarter of 2018 (“2018 Q3”) is \$173,430,008, and the CCP direct spend with DEP NC contractors over the same period is \$20,477,117.

The NC Local Economic Impact reflected on Exhibit A demonstrates an increase in NC employment by approximately 2,258 from NC headquartered companies. This is a conservative estimate of the true NC Local Economic Impact as the figures on Exhibit A do not include spends with companies headquartered outside of NC. For example, Duke Energy works with many companies headquartered outside of NC that utilize NC workers and that provide further positive economic impact.

Regarding the CCP support of local suppliers, below is a list of the top 10, NC based contractors supporting CCP work for DEC and DEP. Note that these are firms with their headquarters, or remit address, in North Carolina and does not include non-headquartered contractors (*though they may have local offices in NC*) actively performing work in NC.

Additionally, Duke Energy recently solicited input on NC economic impacts via questionnaire from thirty-two (32) companies performing CCP work in NC that have headquarters outside of NC. Duke Energy received 32 responses that are summarized on Exhibit B to this filing. According to the responses, these non-NC headquartered companies, during the 2017 Q4 through 2018 Q3 timeframe, have employed 1,511 NC residents, of which 809 are minorities. The total new hires of NC residents during the 2017 Q4 through 2018 Q3 time period is 764 NC residents for these non-NC headquartered companies.

A conservative estimate on NC residents employed as the result of CCP work is 3,769 (2,258 + 1,511), which includes NC residents directly employed by NC headquartered companies, indirect labor, and induced labor plus NC residents directly employed by non-NC headquartered companies.

A breakdown of the demographics of the 809 minorities employed by these non-NC headquartered companies is shown below:
