MOTION FOR  
EXTENSION OF TIME

NOW COMES WILKINSON SOLAR LLC (“Wilkinson”), by and through its counsel, and respectfully requests an extension of time in this matter. In support of this motion, Wilkinson shows the following:

1. At the evidentiary hearing on May 23, 2017, Presiding Commission Brown-Bland “encourage[d] all parties to come together . . . before there is an order coming from this body to see what arrangements can be made . . . I would encourage [] communication, compromise, and resolution . . . .”
2. On August 3, 2017, the Commission issued an Order which required the parties to submit additional filings addressing the status of negotiations and providing a forecast of whether a compromise is likely. The Order required that these filings be made on or before August 15, 2017.
3. Wilkinson has been negotiating in earnest with counsel for the Terra Ceia Christian School and David Butcher and are nearing an agreement in principal.
4. Due to the ongoing negotiations, Wilkinson respectfully requests an extension of time to Thursday, August 17, 2017, for parties to make the required post-hearing filings.

5. Wilkinson is authorized to represent that Mr. Butcher, the only other party in this matter who is participating in the negotiations, does not oppose this motion. The only other party in this matter is the Public Staff, which is not part of the negotiations and is not required to file the post-hearing filings contemplated by the August 3, 2017 Order.

WHEREFORE, Wilkinson Solar LLC respectfully requests that the Commission enter an order extending the time to file post-hearing filings to Thursday, August 17, 2017.
