In compliance with ordering paragraph number 8 of the Commission's September 21, 2021, Order Establishing Discovery Guidelines, Scheduling Hearings, and Requiring Customer Notice issued in the above referenced docket, on behalf of Old North State Water Company, LLC ("ONSWC" or "Company"), please find ONSWC's Responses to Public Staff's Data Requests Numbers 33 and 55 as they pertain to updates to revenues, expenses, and rate base.
