Dear NC Utilities commission, I am a customer who does not wish to have a smart meter. I am in the process of trying opting out of having a smart meter on my house. I am writing in to urge you to decline Duke Energy Progress's request to be able to suspend it's opt-out program in the future. There are health risks for many individuals in regard to "smart" meters. Many people, such as myself and my family, do not wish to be exposed to pulsed radio-frequency radiation (24/7) from these meters in our homes without consent of the customer. While it seems appropriate that customers would have the option choose to have smart meters if they would like one, it should, however, always remain a choice of the homeowner/ customer whether they would like this meter or not. Because of documented health risks, there should always be an opt-out option for customers. Duke should never be allowed to suspend this option, now or at any point in the future. An analogue option should also always be available for customers who do not opt for smart meters, even if the analogue option must be at the customer's expense. Analogue meters are not associated with health risks. Finally, in regard to discussions about requiring a notary requirement for an MD letter. My physician (as well as many other physician's office) do not have a notary available in their office. If a MD letter is required, I would urge that the notary requirement be dropped. NC is the only state currently requiring an MD letter. Thank you for your consideration, Cathy Foister

They can have an analog meter and average/estimate the bill checking the meter every 6 months or once a year. It is "always feasible". —and we need for Duke Energy to NOT be allowed to simply discontinue an individual's Opt-out status after the 1st year with 30 days written notice. We need to be secure in knowing that when we opt-out, it is for good. My patients cannot just opt-out of their sensitivities, they need to know that their opt-out is forever. I am writing concerning the NCUC smart meter "opt-out" currently being planned by Duke Energy Progress. This so-called "opt-out" option is not an opt-out at all as these meters are still very dangerous, even with the radio off. This is interfering with my ability to lead to a normal life, go where I need to go, live where I want to live, and work wherever I choose. All of this has become impossible. I have become fearful of leaving my house due to extreme sensitivity. Do let Duke Energy get away with this false "opt-out" energy. They need to be held both liable and accountable for all of the illness they have already caused and all of the illness they have yet to cause. The people responsible for imposing this lethal and toxic technology on others should be imprisoned for life. And beware the trojan horse analog meters some of these wretched utility companies have invented in order to trick people. If the meter has an FCC number on it, it is a TRANSMITTING meter. This is not acceptable under and circumstances. Only a NON-TRANSMITTING ANALOG METER will do.
