Pursuant to Ordering Paragraph 3 of the North Carolina Utilities Commission's ("Commission") June 14, 2019 *Order Approving Revised Interconnection Standard and Requiring Reports and Testimony* ("Order"), Virginia Electric and Power Company, d/b/a Dominion Energy North Carolina ("DENC" or "the Company"), is providing its *Annual Interconnection Requests and Fee Revenue Report* for filing in the above-referenced proceeding.

Ordering Paragraph 3 requires the Utilities to file by March 1 of each year a "verified report showing interconnection-related expenses and revenues associated with fee-related work for the prior year." Due to administrative oversight, the Company missed the March 1 filing date for this submission and asks that the Commission accept its updated report contained herein out-of-time for purposes of DENC's compliance with this directive.

The Discussion and Conclusions related to this requirement is largely supported by testimony from the Duke Utilities and further clarifies that the report should include "the volume of Interconnection Requests received, the amount of fees collected pursuant to the NC Interconnection Standard, and the Duke Utilities' actual expenses incurred for interconnection-related work." Order at 17. The Order also requires the Utilities to include information regarding the number of post-commissioning and periodic inspections conducted each year. Order at 21. The relevant information for DENC for calendar year 2020 is:
