Withdrawal of Appearance

Pursuant to North Carolina General Statutes (“N.C.G.S.”) Sections 62-60 and 84-4.1, and the North Carolina Utility Commission’s Rules of Practice and Procedure, Sierra Club and Natural Resources Defense Council (“NRDC”) wish to withdraw as active parties to this proceeding and their counsel C. Edward Teague and David Wooley, respectfully request to withdraw their appearance for these parties in this proceeding. In support of these requests, Sierra Club, NRDC and their counsel state as follows.

1. By orders of the Commission, NRDC and Sierra Club were granted intervention to participate as parties in this proceeding, and David Wooley was granted leave for limited permission to practice before the Commission.
2. Sierra Club and NRDC participated actively in the initial phases of this proceeding ending with the Commission’s Order of December 31, 2014.
