BY THE PRESIDING COMMISSIONER: On October 5, 2020, the Public Staff – North Carolina Utilities Commission (Public Staff) filed with the Commission a Motion for Leave to Leave to File Corrected Exhibit of Jay B. Lucas in the above dockets. In summary, the Public Staff stated that it was notified on October 1, 2020, by counsel for Duke Energy Progress, LLC (DEP), that DEP had inadvertently provided the Public Staff with incorrect information in response to a Public Staff data request on March 2, 2020, and that the Public Staff relied on the incorrect information in creating its Corrected Lucas Exhibit 18, which it filed with the April 23, 2020 supplemental testimony of Public Staff witness Jay B. Lucas. Accordingly, the Public Staff requested leave to file a Second Corrected Lucas Exhibit 18 to reflect the corrected information. The Public Staff represented that it contacted all parties and – with the exception of Harris Teeter, LLC and the North Carolina Clean Energy Business Alliance (NCCEBA) who did not respond – all parties stated that they did not object to the motion.

Based on these representations and the records in these dockets, the Presiding Commissioner finds good cause to allow the motion. The Public Staff may file a Second Corrected Lucas Exhibit 18 to reflect the corrected information it received.

IT IS, THEREFORE, SO ORDERED.
