B. <u>NATURAL GAS</u>

P1. DOCKET NO. G-5, SUB 584 – APPLICATION OF PUBLIC SERVICE COMPANY OF NORTH CAROLINA, INC., FOR AUTHORIZATION TO CONSTRUCT APPROXIMATELY 1,730 FEET OF 4-INCH DIAMETER NATURAL GAS PIPELINE FACILITIES WITHIN THE TERRITORY OF PIEDMONT NATURAL GAS COMPANY, INC.

EXPLANATION: On January 9, 2018, Public Service Company of North Carolina, Inc. (PSNC) filed an application with the Commission for authority to construct and operate natural gas pipeline facilities in Mecklenburg County pursuant to Commission Rule R6-61. The application indicates that PSNC proposes to construct approximately 1,730 feet of 4-inch diameter pipeline (PSNC Main) in the service territory of Piedmont Natural Gas Company, Inc. (Piedmont), in Mecklenburg County, North Carolina. The proposed PSNC Main will connect to PSNC's planned system extensions. The PSNC Main will not serve any customers within Piedmont's service territory.

Commission Rule R6-61 requires a natural gas local distribution company to obtain Commission approval prior to constructing or operating a pipeline outside of its designated territory, and in this case facilities will be constructed in Piedmont's territory. PSNC states that the proposed pipeline is necessary to serve the proposed subdivision of Holcombe Woods, which is wholly located in Cabarrus County, PSNC's franchised territory. In order to effectively serve Holcombe Woods Subdivision, the PSNC Main will need to cross a portion of Piedmont's exclusive service territory in Mecklenburg County.

The application states that PSNC notified Piedmont of this project, and Piedmont had no objection to the construction and operation of the PSNC Facilities in Mecklenburg County.

The Public Staff has reviewed the application and some background information provided by PSNC in response to a Public Staff data request.

The Public Staff recommends that the Commission issue an order granting PSNC authority to construct the proposed pipeline.

RECOMMENDATION: (Gilbert) That the Commission issue the proposed order approving PSNC's request.

P2. DOCKET NO. G-9, SUB 717 – APPLICATION OF PIEDMONT NATURAL GAS COMPANY, INC., FOR AN ADJUSTMENT OF ITS RATES AND CHARGES TO TRACK CHANGES IN ITS WHOLESALE COSTS OF GAS

EXPLANATION: On January 18, 2018, Piedmont Natural Gas Company, Inc. (Piedmont), filed an application pursuant to G.S. 62-133.4, Commission Rule R1-17(k)(3), and Appendix A of Piedmont's North Carolina Service Regulations, seeking authority to decrease its sales rates by \$0.2548 per dekatherm (dt) and its transportation rates by \$0.0048 per dt effective February 1, 2018, due to a change in its Benchmark Cost of Gas from the current rate of \$2.75 per dt to \$2.50 per dt.

The Public Staff has reviewed the application and recommends approval as filed.

EXHIBIT: A proposed order is attached as Exhibit No. P-2.

RECOMMENDATION: (Naba) That the Commission issue the proposed order approving the rate changes proposed by Piedmont.

E. <u>WATER</u>

P1. <u>DOCKET NO. W-218, SUB 487 – AQUA NORTH CAROLINA, INC. – REQUEST FOR TARIFF REVISION</u>

EXPLANATION: On December 11, 2017, Aqua North Carolina, Inc. (Aqua), filed a verified petition, pursuant to G.S. 62-133.11, with the Commission requesting authority to amend its tariff for the purpose of passing along to its water customers in Crestwood, Lancer Acres, and Beard Acres Subdivisions in Randolph County an increase in the cost of purchasing water service from Davidson Water, Inc. (Davidson Water).

Effective January 1, 2018, Davidson Water increased its rates charged to Aqua as follows:

Aqua's current rates have been in effect since March 27, 2017, when they were approved by the Commission in its Order Approving Tariff Revision issued in Docket No. W-218, Sub 445. After taking into account the effect of the 0.14% regulatory fee, Aqua has requested authority to increase its water usage rate from \$5.19 to \$5.30 per 1,000 gallons.

The Public Staff has reviewed Aqua's petition and recommends that the requested tariff revision be approved. The Public Staff is of the opinion that the tariff revision will allow Aqua to recover additional revenues that do not exceed the additional expenses.

Under the new recommended rates, the typical residential customer's monthly water bill will increase by \$0.55, from \$43.87 to \$44.42 based upon 5,000 gallons usage.

RECOMMENDATION: (Junis/Cooper/Grantmyre) That the Commission issue the Public Staff's proposed order approving the requested tariff revision.

P2. <u>DOCKET NO. W-1075, SUB 12 – KRJ UTILITIES COMPANY – APPLICATION FOR RATE INCREASE</u>

EXPLANATION: On January 10, 2018, KRJ Utilities Company (KRJ or Applicant) filed an application seeking authority to increase its rates for water utility service in Southern Trace Subdivision and water and sewer utility service in Rockbridge Subdivision in Wake, County, North Carolina. KRJ serves approximately 428 metered water customers and 236 flat rate sewer customers. The present rates have been in effect since approved by the Commission for Southern Trace in general rate case Order dated January 14, 2005, in Docket No. W-1075, Sub 4, and for Rockbridge in the Order Granting Certificate of Public Convenience and Necessity and Approving Rates dated November 30, 2006, in Docket No. W-1075, Sub 5. The approved rates for both Southern Trace and Rockbridge were subsequently reduced for the repeal of the gross receipts tax and corporate tax rate reductions.

The Applicant's present and proposed rates are as follows:

The proposed rates would increase the average residential monthly water bill from \$32.81 to \$59.72, an 80.02% increase, based on an average monthly usage of 5,145 gallons.

The proposed rates would increase the average residential monthly water bill from \$22.07 to \$52.92, a 139.78% increase, based on an average monthly usage of 5,145 gallons, and the monthly flat sewer rate from \$68.33 to \$105.37, a 54.21% increase.

BY THE COMMISSION: On January 9, 2018, Public Service Company of North Carolina, Inc. (PSNC), filed an application with the Commission for authority to construct and operate natural gas pipeline facilities in Mecklenburg County pursuant to Commission Rule R6-61. The application indicates that PSNC proposes to construct approximately 1,730 feet of 4-inch diameter pipeline (PSNC Main) in the service territory of Piedmont Natural Gas Company, Inc. (Piedmont), in Mecklenburg County, North Carolina. The proposed PSNC Main will connect to PSNC planned system extensions. The PSNC Main will not serve any customers within Piedmont's service territory.

Commission Rule R6-61 requires a natural gas local distribution company to obtain Commission approval prior to constructing or operating a pipeline outside of its designated territory, and in this case facilities will be constructed in Piedmont's territory. PSNC stated that the proposed pipeline is necessary to serve the proposed subdivision of Holcombe Woods, which is wholly located in Cabarrus County, PSNC's franchised territory. In order to effectively serve Holcombe Woods Subdivision, the PSNC Main will need to cross a portion of Piedmont's exclusive service territory in Mecklenburg County. PSNC stated that Piedmont indicated that it has no objection to the proposed route.

The Public Staff presented this matter at the Commission's Regular Staff Conference on January 29, 2018, and stated that it had reviewed the application and information provided by PSNC in response to a Public Staff data request.

The Public Staff recommended that the Commission issue an order granting PSNC authority to construct the proposed pipeline.

BY THE COMMISSION: On January 18, 2018, Piedmont Natural Gas Company, Inc. (Piedmont), filed an application pursuant to G.S. 62-133.4, Commission Rule R1-17(k)(3), and Appendix A of Piedmont's North Carolina Service Regulations, seeking authority to decrease its sales rates by \$0.2548 per dekatherm (dt) and its transportation rates by \$0.0048 per dt effective February 1, 2018, due to a change in its Benchmark Cost of Gas from the current rate of \$2.75 per dt to \$2.50 per dt.

The matter was presented to the Commission at its Regular Staff Conference on January 29, 2018. The Public Staff stated that it had reviewed the application and recommended approval as filed.

Based upon the review of the application and the recommendation of the Public Staff, the Commission is of the opinion that the proposed rate changes should be allowed to become effective as filed.

IT IS, THEREFORE, ORDERED as follows:

- 1. That Piedmont is authorized to decrease its sales rates by \$0.2548 per dt effective for service rendered on and after February 1, 2018.
- 2. That Piedmont is authorized to decrease its transportation rates by \$0.0048 per dt effective for service rendered on and after February 1, 2018.
- 3. That Piedmont shall file revised tariffs consistent with Ordering Paragraphs 1 and 2 within five (5) days of the date of this Order.
- 4. That Piedmont shall give notice to its customers of the rate changes allowed in this Order.

After taking into account the effect of the 0.14% regulatory fee, Aqua has requested authority to increase its water usage rate from \$5.19 to \$5.30 per 1,000 gallons.

Under the new recommended rates, the typical residential customer's monthly water bill will increase by \$0.55, from \$43.87 to \$44.42 based upon 5,000 gallons usage.

- 1. That Aqua North Carolina, Inc., is granted a revision to Appendix A-2 of its tariff for water utility service in Crestwood, Lancer Acres, and Beard Acres Subdivisions in Randolph County, in which it purchases and resells water from Davidson Water, Inc., as set forth herein.
- 2. That the revised Appendix A-2 attached hereto, is approved and is deemed filed with the Commission pursuant to G.S. 62-138. This Schedule of Rates shall become effective for service rendered on and after the date of this Order.
- 3. That the Notice to Customers, attached hereto as Appendix B, be mailed with sufficient postage or hand delivered by Aqua to all of its affected customers in Crestwood, Lancer Acres, and Beard Acres Subdivisions contemporaneously with the next billing of customers; and that Aqua submit to the Commission the attached Certificate of Service, properly signed and notarized, no later than 10 days after the date of the next billing.

BY THE COMMISSION: On January 10, 2018, KRJ Utilities Company (KRJ or Applicant) filed an application with the Commission seeking authority to increase its rates for water utility service in Southern Trace Subdivision and water and sewer utility service in Rockbridge Subdivision in Wake, County, North Carolina. KRJ serves approximately 428 metered water customers and 236 flat rate sewer customers. The present rates have been in effect since approved by the Commission for Southern Trace in general rate case Order dated January 14, 2005, in Docket No. W-1075, Sub 4, and for Rockbridge in the Order Granting Certificate of Public Convenience and Necessity and Approving Rates dated November 30, 2006, in Docket No. W-1075, Sub 5. The approved rates for both Southern Trace and Rockbridge were subsequently reduced for the repeal of the gross receipts tax and corporate tax rate reductions.

The Applicant's proposed rates would increase the average residential monthly water bill from \$22.07 to \$52.92, a 139.78% increase, based on an average monthly usage of 5,145 gallons and the monthly flat sewer rate from \$68.33 to \$105.37 a 54.21% increase.

That the Notice to Customers, attached as Appendix A, be mailed with sufficient postage or hand delivered by the Applicant to all customers affected by the proposed new rates; that the Notice to Customers be mailed or hand delivered no later than 14 days after the date of this Order; and that the Applicant submit to the Commission the attached Certificate of Service properly signed and notarized not later 30 days after the date of this Order.

However, any rate structure considered will not generate more overall revenues than requested.

EFFECT OF RATES

The proposed rates in **Southern Trace Subdivision** would increase the average residential monthly water bill from \$32.81 to \$59.72, an 80.02% increase, based on an average monthly usage of 5,145 gallons.

The proposed rates in **Rockbridge Subdivision** would increase the average residential monthly water bill from \$22.07 to \$52.92, a 139.78% increase, based on an average monthly usage of 5,145 gallons and the monthly flat sewer rate from \$68.33 to \$105.37 a 54.21 % increase.
