NOW COMES Western Carolina University ("WCU"), by and through counsel, and respectfully moves that the North Carolina Utilities Commission (the "Commission") issue an Order extending until Wednesday, November 11, 2020 the time for WCU to file its tariff sheets and for WCU and the Public Staff to jointly prepare and file a proposed customer notice addressing the rate increase approved by the Commission in this proceeding. In support of this motion, WCU states as follows:

1. On October 29, 2020, the Commission issued an Order Granting General Rate Increase and Accepting Stipulation (the "Order") in Docket No. E-35, Sub 51. In ordering paragraph 2 thereof, the Commission directed WCU to "file tariff sheets within ten days from the date of this Order reflecting the rates and fees designed to produce the increase in revenues as approved herein."

2. In ordering paragraph 3 of the Order, the Commission directed WCU and the Public Staff to "jointly prepare and within ten days of the date of this Order file a proposed customer notice addressing the rate increase approved herein, effective for bills rendered on and after December 1, 2020."

3. Ten days from the date of the Order would be Sunday, November 8, 2020.

4. In pursuance of ordering paragraphs 2 and 3 of the Order, WCU submitted to the Public Staff for its review proposed final rates and a draft customer notice on October 29, 2020.

6. On Thursday, November 5, 2020, the Public Staff responded with revisions to WCU's proposed draft, necessitating additional review by WCU.

7. Due to the press of other business commanding the time and attention of the Parties, the Parties do not anticipate having sufficient time to review and reach a final agreement regarding the tariff sheets and proposed customer notice in time to meet the filing deadline set by the Order.

5. That WCU has conferred with the Public Staff prior to making its motion, and that the Public Staff has authorized WCU to state that the Public Staff does not oppose the extension sought herein.

WHEREFORE, WCU respectfully requests that the Commission approve an extension of time up to and including Wednesday, November 11, 2020, for the filings required by ordering paragraphs nos. 2 and 3 of the Order.
