Biologists with the North Carolina Wildlife Resources Commission (NCWRC) have reviewed the subject document and are familiar with the habitat values of the area. Our comments are provided in accordance with provisions of North Carolina General Statutes (G.S. 113-131 et seq.) Sections 401 and 404 of the Clean Water Act, as amended, and the Fish and Wildlife Coordination Act (48 Stat. 401, as amended; 16 U.S.C. 661 et seq.).

The applicant proposes to construct a 120 MW solar facility located in the vicinity of 922 Oak Grove Church Road, 207 Summit Trail, 131 Oak Grove Church Road, 172 Oak Grove Church Road, 1315 Oak Grove Church Road, 105 Crossvine Lane, and 610 Cherry Tree Road in Gaston, NC. This is Phase 1, 120 MW, of a 300 MW facility (Gaston Green Acres Solar, LLC – OLIA No. 21-0750).

A map of the proposed project site indicates portions of the area are vegetated. In general, the NCWRC supports solar facilities located in open areas. However, the conversion of forests and wetlands to support solar development is causing increasing concern due to the loss of wildlife habitat, the fragmentation of wildlife habitat, and vegetative management needed post conversion for wetland and other forested areas. Due to the importance of wetlands to wildlife, we would like to state concern with any portion of the proposed project that would impact riparian areas, wetlands, or jurisdictional stream features. This also includes the change of vegetation outside the panel layout.

This project is an exceptionally large solar facility. The cumulative loss of vegetation increases the loss of wildlife habitats, causes habitat fragmentation, and may have significant adverse impacts to watershed input to wetland and stream features during and after construction.

The installation of fence significantly affects wildlife travel and potentially stream flow and bank stabilization depending on crossing proposals. Fence installation should not negatively affect normal or

large event flows or cause water damming and collection of debris. Fence crossing of jurisdictional features should be done in areas where crossings already occur. Careful consideration should be given to all aspects of development.

In addition to the concerns above, the following statements should be observed:

- Maintain or establish a minimum 100-foot undisturbed, native forested buffer along each side of
 perennial streams and 50-foot undisturbed, native forested buffer along each side of intermittent
 streams and wetlands. Forested riparian buffers provide habitat areas for aquatic and terrestrial
 wildlife species and travel corridors for terrestrial wildlife. In addition, forested riparian buffers
 protect water quality by stabilizing stream banks and filtering stormwater runoff.
- 2. Use bridges for all permanent roadway crossings of streams and associated wetlands to eliminate the need to fill and culvert, where practicable. If culverts must be used, the culvert should be designed to allow aquatic life passage. Fords may be appropriate and preferred for intermittent stream crossings or where crossings will be used only once or twice a year. For fords, crossings in riffles are preferred with the banks lowered upstream and downstream of the crossing. Stabilize the stream bottom with geo-textile fabric and rock; concrete should not be used for bed stabilization.
- 3. Avoid or minimize impacts to wetlands during construction. In addition to providing wildlife habitat, wetland areas perform important functions of flood control and water quality protection. US Army Corps of Engineers Section 404 permits and NC Division of Water Resources Section 401 Certifications are required for any impacts to jurisdictional streams or wetlands. Temporarily disturbed wetland areas should be returned to original soils and contours, and reseeded with annual small grains appropriate for the season (e.g. oats, millet, rye, wheat, or rye grass) and should be allowed to revert to natural wetland vegetation.
- 4. If additional overhead transmission lines will be installed, then measures to minimize impacts to birds should be implemented. These can include increasing line visibility, insulating wires to cover exposed connections, and increasing the distance between wires so no contact with ground or other energized wire can be made. For more information see http://www.fws.gov/birds/documents/powerlines.pdf.
- 5. Consider establishing vegetative cover on the site that is beneficial to wildlife. Plantings should include native warm season grasses and/or wildflower seed mixes to create pollinator habitat within the project boundary. Shade-tolerant plants that are grow between 12 to 18 inches can be selected for planting both underneath and around solar panels. This type of planting is especially important due to the vast scope of the project. Pollinator habitat can also be created in buffer areas outside of the panel region. In addition, consider adding other habitat-enhancing features, such as permeable fencing, bat boxes and brush piles that will minimize impacts from habitat loss. Further information and free technical guidance from the NCWRC are available upon request.
- 6. If site and/or transmission line maintenance is needed, avoid mowing between April 1 and October 1 to minimize impacts to nesting wildlife. We suggest a maintenance schedule that incorporates a portion of the area (e.g., one-third of the area) each year. Pesticides, fertilizers, herbicides, and other chemicals should not be used in wetland areas or near streams.

- 7. If pesticides or chemicals will be used for site maintenance, then stormwater runoff from the site should be directed to bio-retention areas prior to discharge to streams or wetlands to provide additional protection for water quality and aquatic and terrestrial wildlife habitats.
- 8. Sediment and erosion control measures should be installed prior to any land clearing or construction. The use of biodegradable and wildlife-friendly sediment and erosion control devices is strongly recommended. Silt fencing, fiber rolls and/or other products should have loose-weave netting that is made of natural fiber materials with movable joints between the vertical and horizontal twines. Silt fencing or similar materials that have been reinforced with plastic or metal mesh should be avoided as they impede the movement of terrestrial wildlife species. All sediment and erosion control measures should be routinely inspected and properly maintained. Excessive silt and sediment loads can have numerous detrimental effects on aquatic resources including destruction of spawning habitat, suffocation of eggs, and clogging of gills of aquatic species.
- 9. A plan should be developed that identifies the party responsible for decommissioning the facility as well as the conditions under which decommissioning will occur. In addition, the plan should emphasize that all equipment must be removed from the sites, and the land should be restored to pre-construction conditions.

The Division of Waste Management, Solid Waste Section (Section) has reviewed the documents submitted for the subject project in Northampton County, NC. Based on the information provided in this document, the Section at this time does not see an adverse impact on the surrounding communities and likewise knows of no situations in the communities, which would affect this project.

As always for any planned or proposed projects, it is recommended that during any land clearing, demolition and construction, the Oak Solar LLC and/or its contractors would make every feasible effort to minimize the generation of waste, to recycle materials for which viable markets exist, and to use recycled products and materials in the development of this project where suitable. Any waste generated by and of the projects that cannot be beneficially reused or recycled must be disposed of at a solid waste management facility permitted by the Division. The Section strongly recommends that the Oak Solar LLC Corporation require all contractors to provide proof of proper disposal for all generated waste to permitted facilities.



Thank you for your submission concerning the above referenced project. We have reviewed the materials provided and offer the following comments.

There are no recorded archaeological sites within the project area. However, the project area has never been systematically surveyed to determine the location or significance of archaeological resources. The project area contains ridges adjacent to the Roanoke River and Beddingfield Creek, which are landforms that have a high probability for containing archaeological sites.

We recommend that prior to any ground disturbing activities within the project area, a comprehensive archaeological survey be conducted by an experienced archaeologist. The purpose of this survey will be to identify and evaluate the significance of archaeological sites and cemeteries that may be damaged or destroyed by the proposed project.

Please note that our office now requests consultation with the Office of State Archaeology Review Archaeologist to discuss appropriate field methodologies prior to the archaeological field investigation. A list of archaeological consultants who have conducted or expressed an interest in contract work in North Carolina is available at <u>https://archaeology.ncdcr.gov/archaeological-consultant-list</u>. The archaeologists listed, or any other experienced archaeologist, may be contacted to conduct the recommended survey.

One paper and one digital copy of all resulting archaeological reports, as well as one digital copy of the North Carolina site form for each site recorded, should be forwarded to the Office of State Archaeology through this office for review and comment as soon as they are available and in advance of any construction or ground disturbance activities. We have determined that the project as proposed will not have an effect on any historic structures.
