**SECOND MOTION OF DUKE
ENERGY CAROLINAS, LLC AND
DUKE ENERGY PROGRESS, LLC
FOR EXTENSION OF TIME TO FILE
COMMENTS**

NOW COME Duke Energy Carolinas, LLC and Duke Energy Progress, LLC (the “Companies”), by and through counsel and pursuant to Rule R1-7 of the Rules and Regulations of the North Carolina Utilities Commission (“Commission”), and respectfully request that the Commission enter an order granting a three-week extension of time for all parties to file initial comments and reply comments in this proceeding.

The Companies show the Commission the following:

1. On November 20, 2018, the Companies filed requests for approval of the Renewable Advantage Program Rider with the Commission.

2. On November 30, 2018, the Public Staff of the North Carolina Utilities Commission (the “Public Staff”) filed a motion to suspend tariffs and request comments.

3. On December 12, 2018, the Commission issued an *Order Suspending Proposed Tariffs and Requesting Comments and Proposed Orders*, directing parties to file initial comments on or before January 3, 2019 and reply comments on or before January 17, 2019.


4. On December 28, 2018, the Companies requested an extension of time for all parties to file initial and reply comments, which the Commission granted on December 31, 2018, directing parties to file comments by January 17, 2019 and reply comments by January 31, 2019.

5. The Companies are reviewing the proposed programs in light of discussions with the Public Staff, and additional time may allow consensus to be reached on outstanding issues.

6. The Companies have notified counsel for the Public Staff and NC Sustainable Energy Association that they intended to seek an extension of time, and counsel did not object to the extension.

WHEREFORE, the Companies respectfully request that the Commission grant an extension until February 7, 2019 for all parties to file initial comments and until February 21, 2019 for all parties to file reply comments, and any such further relief as the Commission deems just and proper.
