Pursuant to North Carolina General Statutes (“N.C.G.S.”) §§ 62-60 and 840-4.1 and Rule R1-22 of the North Carolina Utilities Commission’s (“Commission”) Rules of Practice and Procedure, Heather S. Smith (“Ms. Smith”), of Duke Energy Carolinas, LLC, respectfully request the Commission to enter an order admitting her to practice before the Commission for the purpose of appearing on behalf of Duke Energy Carolinas, LLC (“Duke Energy Carolinas” or “Company”) in the above captioned proceeding. In support of this Motion, Ms. Smith alleges and shows the Commission that:

1. The above-captioned matter is a regulatory proceeding before the North Carolina Utilities Commission, governed by North Carolina public utility law.
2. Duke Energy Carolinas is a public utility under the laws of North Carolina and its operations in this State are subject to the jurisdiction of this Commission.


9. Ms. Smith has not been disciplined by any court or lawyer regulatory organization nor have either of them had any *pro hac vice* revoked.






