BY THE PRESIDING COMMISSIONERS: On August 31, 2013, Dominion North Carolina Power filed its 2013 integrated resource plan (IRP), and related 2013 Renewable Energy and Energy Efficiency Portfolio Standard (REPS) compliance plan (collectively, Sub 137 Plans) in Docket No. E-100, Sub 137 (Sub 137). In addition, based on the Commission's September 24, 2013 Order Granting Further Extension of Time in Sub 137, Duke Energy Progress, Inc., and Duke Energy Carolinas, LLC, are required to file their Sub 137 plans on or before October 15, 2013.

Between August 19, 2013 and September 4, 2013, the municipal electric power suppliers and electric membership corporations filed their 2013 REPS compliance plans and 2012 REPS compliance reports (collectively, Sub 139 Reports), in Docket No. E-100, Sub 139 (Sub 139).

Pursuant to Commission Rule R8-60(j) and Rule R8-67(b)(3), the Public Staff and other intervenors may file comments on the Sub 137 Plans within 60 days of the date on which the plans are filed. In addition, Rule R8-60(j) allows parties to file reply comments within 14 days of the initial comments. Thus, the dates for filing comments on the Sub 137 Plans range from October 31, 2013 through December 14, 2013.

On October 4, 2013, the Public Staff filed a Motion in Docket No. E-100, Subs 137 and 139 requesting that the Commission designate Tuesday, February 4, 2014, as the date for the Public Staff and other intervenors to file comments on the Sub 137 Plans and the Sub 139 Reports. In support of its motion, the Public Staff states, among other things, that the Public Staff has traditionally filed consolidated comments on the IRPs and REPS compliance plans in a single filing, and that the

Public Staff intends to follow this practice for the 2013 IRPs and REPS compliance plans. However, because of the complexity of the issues raised by the IRPs and REPS compliance plans and the press of other business, the Public Staff requests that the Commission set February 4, 2014, as the date for the Public Staff and other intervenors to file initial comments on the Sub 137 Plans and the Sub 139 Reports.

Based upon the records in Subs 137 and 139, and the Public Staff's motion, the Presiding Commissioners find good cause to establish Tuesday, February 4, 2014, as the date by which interested persons may file petitions to intervene in Subs 137 and 139, and as the date by which the Public Staff and other intervenors may file comments on the Sub 137 Plans and Sub 139 Reports. Further, the Presiding Commissioners find good cause to establish Tuesday, February 18, 2014, as the date by which all parties may file reply comments in Subs 137 and 139.

IT IS, THEREFORE, ORDERED as follows:

- 1. That on or before Tuesday, February 4, 2014, persons having an interest in Docket Nos. E-100, Sub 137 and E-100, Sub 139 may file petitions to intervene stating such interest.
- 2. That on or before Tuesday, February 4, 2014, the Public Staff and other intervenors may file initial comments on the IRPs and REPS compliance plans in Docket No. E-100, Sub 137, and the REPs compliance reports and compliance plans in Docket No. E-100, Sub 139.
- 3. That on or before Tuesday, February 18, 2014, all parties may file reply comments on the IRPs and REPS compliance plans in Docket No. E-100, Sub 137, and the REPs compliance reports and compliance plans in Docket No. E-100, Sub 139.
