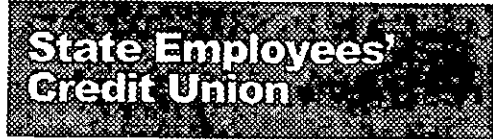

Dear Member of the North Carolina Utilities Commission:


