On February 1, 2018, Public Service Company of North Carolina, Inc. ("PSNC"), filed an Application to Refund Overcollection ("Application") in the above referenced dockets. In the Application PSNC indicated that it was in the process of determining the additional amounts collected from customers and that it would make an additional filing when the final amount to be refunded was determined. PSNC has determined that the amount to be refunded, excluding interest, is $\$ 479,271.52$. As set forth on Attachment 1, PSNC has calculated interest on the refund through December 31, 2017.
