Re: Implementation by the North Carolina Utilities Commission (the Commission) of Executive Order No. 142 (Previously EO No. 124)

Dear Governor Cooper:

This report covers activities related to EO 142 for the period beginning June 1, 2020 and ending June 30, 2020 (the Reporting Period). This report is the third for which the Reporting Period spans one month and builds upon the data collected for reports previously submitted on April 13, 20, and 27, May 4 and 15, and June 19. This report includes information provided by 365 Utility Service Providers,¹ more than half of all Utility Service Providers in North Carolina. Most of the state's large and mid-sized providers submitted reports and most of the providers that did not report serve limited numbers of customers.

On May 12, 2020, the Attorney General's Office granted waiver of the reporting requirements for five "foreign" electric membership corporations.² These EMCs are headquartered outside of North Carolina, and their billing systems do not allow them to track North Carolina customers separately from their other customers. In requesting the waiver, these five EMCs committed to continue to abide by the requirements of EO 124 for disconnects, penalties, and repayments.

Of the 365 Utility Service Providers that reported, 73 are electricity providers, nine are natural gas providers, and 283 are providers of water and/or wastewater services. Additionally, of those 365 Utility Service Providers that reported, 279 are governmental or quasi-governmental entities, 43 are investor-owned, and 43 are member-owned.

Residential Accounts³

During the Reporting Period, an additional⁴ 490,845 residential customer accounts became eligible for disconnection due to non-payment but were not disconnected, which is an increase of 37,358 from the 453,487 accounts which were reported in May. Between April 1 and June 30, 1,369,786 residential customer accounts⁵ have become eligible for disconnection but have not been disconnected.

The Utility Service Providers report that 13,172 extended repayment plans were established for residential customers during the Reporting Period, a decrease from the 15,492 reported in May. Between April 1 and June 30, 43,302 extended repayment plans have been established across the state.

Additionally, 1,024 residential customers were reconnected during the Reporting Period, slightly up from 942 in May. Since April 1, 2,969 customers have been reconnected in North Carolina by reporting Utility Service Providers.

Finally, \$10,545,275 in late fees and penalties were not charged to residential customers during the Reporting Period. This is \$505,729 more than in May, and since April 1, reporting Utility Service Providers have not charged \$31,294,508 in late fees and penalties.

Non-Residential Accounts

During the Reporting Period, an additional 28,700 non-residential customer accounts became eligible for disconnection due to non-payment but were not disconnected, up slightly from the 27,515 reported in May. This means that between April 1 and June 30, 84,685 non-residential customer accounts have become eligible for disconnection across the state but were not disconnected.

The Utility Service Providers report that 305 extended repayment plans were established for non-residential customers during the Reporting Period, down from 470 in May and making 1,206 in total since April 1. Additionally, 102 non-residential customers were reconnected during the Reporting Period, up from 45 previously with 180 since April 1. Finally, \$1,330,329 in late fees and penalties were not charged to non-residential customers during the Reporting Period, up from \$1,287,231 in May and contributing to \$4,010,985 in total since April 1.

Utility Arrearage

With the transition to the monthly reporting obligation, the Commission requested that the Utility Service Providers provide information regarding their arrearages and past due accounts in order to better understand the financial impact of the COVID-19 crisis on Utility Service Providers and their customers. As this information was not specifically requested in EO 124 or 142, the Commission did not require Utility Service Providers to respond, but 297 out of the 365 respondents did.

³ These numbers may also include non-residential data from the 132 Utility Service Providers that are not able to separate residential and non-residential customer accounts for reporting purposes.

⁴ The Commission notes that Utilities might be misinterpreting this question; some might be providing the total number of accounts currently eligible for disconnection instead of the number of accounts that became eligible for disconnection in the month of June.

⁵ Individual households could be counted two or even three times in this figure if their electricity, natural gas and water accounts were all eligible for disconnection.

As of June 30, Utility Service Providers report an aggregate of \$257,849,540 in residential and non-residential customer arrearages. Of this reported amount, approximately 59% is attributable to the three largest investor-owned electric utilities - Duke Energy Carolinas, Duke Energy Progress, and Dominion Energy.

For the 238 Utility Service Providers that provided the number of past due residential accounts for both May and June, there were 20,210 more residential accounts past due in June than there were in May. The 239 Utility Service providers which reported residential arrearages for both May and June experienced an aggregate increase of arrearages of \$10,869,082, which is a smaller increase than the \$24,208,280 experienced from April to May.

The average percentage of customers with past due accounts for the 291 Utility Service Providers that reported this information was 13.9%, up slightly from an average of 13.7% in May across 256 Utility Service Providers. Forty-six utilities reported that at least 20% of their customer accounts were past due on June 30 and 18 utilities reported that over 40% of their customer accounts were past due. A summary of the distribution of total accounts past due for May and June is provided in Figure 1.



Because some Utility Service Providers elected not to report information related to arrearages, the information reported herein represents partial, and not a complete, impact of the crisis on North Carolina's Utility Service Providers.

Customer Notifications

Utility Service Providers took a variety of actions throughout the Reporting Period to inform their customers of the utility-related provisions of EO 142. Some examples of actions taken include:

- Notice posted at utility office or on door of Town Hall
- Posted Executive Order text and brief description on the Town's website
- Posting on Town's website and on Facebook
- Radio interview with local radio station; press release
- Notification on customer bills
