BY THE CHAIR: On September 14, 2020, the Commission issued an Order Scheduling Hearing, Requiring Filing of Testimony, Establishing Discovery Guidelines, And Requiring Public Notice (Scheduling Order). Ordering Paragraph 5 of the Scheduling Order required Dominion Energy North Carolina (DENC or Company) to publish the notice attached to the Order in a newspaper having general circulation in its service area once a week for two successive weeks beginning at least 35 days prior to the hearing. The Scheduling Order also scheduled a hearing for Tuesday, November 17, 2020, at 10:00 a.m. The Scheduling Order specified that members of the public that would like to testify during the hearing must register in advance of the hearing by no later than 5:00 p.m. on Monday, November 9, 2020.

On October 23, 2020, the Company filed a Petition for Waiver of Notice Requirements requesting the Commission waive the notice requirements of Ordering Paragraph 5 of the Scheduling Order, extend the time for individuals to register to speak at the hearing until 5:00 p.m. on Friday, November 13, 2020, and leave the record open in this proceeding for 35 days from the hearing to allow for public comment. In support of its petition, DENC states that it discovered errors in the testimony of Company witness Beasley that resulted in the overall reduction in the fuel recovery being understated in the first notice. This error results in a change in the proposed fuel rider amount for each customer class.

DENC had previously provided the notice as required in Ordering Paragraph 5 of the Scheduling Order. The Company proposes to re-notice the amended fuel rates by class. Due to the current hearing date of November 17, 2020, the Company would not have sufficient time to time to comply with the requirement of publishing notice at least 35 days prior to the hearing. The Company states in its petition that if the waiver is granted by October 28, 2020, the notice will be published for two weeks prior to the hearing. In addition, the Company proposes allowing members of the public additional time to register to speak at the hearing, and keeping the record of the proceeding open for 35

days after the hearing date to allow customers to submit written comments on the proposed rates.

The Company states in its petition that the Public Staff does not oppose the petition.

Based on the foregoing and the record, the Chair finds good cause to grant the petition waiving the notice requirements of Ordering Paragraph 5 of the Scheduling Order for the amended notice and providing members of the public that would like to testify during the hearing additional time to register with the Public Staff. In addition, the Commission will keep the record in this docket open from 35 days from date of the publication of the amended notice to allow customers to submit written comments on the proposed rates.


IT IS, THEREFORE, ORDERED AS FOLLOWS:

1. That the notice requirements of Ordering Paragraph 5 of the Scheduling Order are waived for the purpose of re-noticing the amended fuel rates;
2. That DENC shall publish the Amended Notice attached hereto as Appendix A in a newspaper or newspapers having general circulation in its service area once a week for two successive weeks;
3. That DENC shall file affidavits of publication of the Amended Notice; and
4. That members of the public that would like to testify during the hearing scheduled for the purpose of considering the annual fuel charge adjustment proceeding for DENC must register in advance of the hearing, no later than 5:00 p.m. on Friday, November 13, 2020, by contacting the Public Staff. The hearing is scheduled to begin on Tuesday, November 17, 2020, at 10:00 a.m. The hearing shall be held remotely via Webex. A link to view the hearing will be available at [www.ncuc.net](http://www.ncuc.net). NOTICE IS HEREBY GIVEN that the North Carolina Utilities Commission has scheduled a public hearing on an annual fuel and fuel-related charge adjustment proceeding for Virginia Electric and Power Company, d/b/a Dominion Energy North Carolina (DENC). The public hearing is scheduled to begin on Tuesday, November 17, 2020, at 10:00 a.m. The hearing will be held remotely via Webex. A link to view the hearing will be available at [www.ncuc.net](http://www.ncuc.net). Members of the public that would like to testify during the hearing must register in advance of the hearing, no later than 5:00 p.m. on Friday, November 13, 2020, by contacting the Public Staff via email at [DENCPublicHearing@psncuc.nc.gov](mailto:DENCPublicHearing@psncuc.nc.gov) or by calling 866-380-9816. When registering, provide your name, docket number (E-22, Sub 590), telephone number, and the topic of your testimony.

**Only individuals registered with the Public Staff by 5:00 p.m. on Friday, November 13, 2020, will be allowed to testify at the hearings.**

DENC filed an application and testimony relative to the subject matter of this proceeding on August 11, 2020. According to its application, DENC is requesting a total annual fuel revenue decrease of approximately \$15.7 million from the fuel and fuel-related costs currently in effect. Further, DENC proposes to make the fuel revenue decrease effective for service on and after February 1, 2021.

DENC's proposed fuel revenue decrease, including regulatory fee, would result in the following decreases for DENC's customers: 0.389 cents per kilowatt-hour (kWh) for residential, outdoor lighting and traffic lighting customers; 0.387 cents per kWh for small general service and public authority customers; 0.384 cents per kWh for large general service customers; 0.372 cents per kWh for rate schedule NS customers; and 0.378 cents per kWh for rate schedule 6VP customers. The net effect of this request would decrease the monthly bill of a residential customer using 1,000 kWh of electricity by \$3.89.


Written statements are not evidence unless persons appear at a public hearing and testify concerning the information contained in their written statements.
