BY THE PRESIDING COMMISSIONER: On June 28, 2019, Carolina Water Service, Inc. of North Carolina (CWSNC or Applicant), filed an application with the

Commission seeking authority to adjust and increase its rates for providing water and sewer utility service in all of its service areas in North Carolina.^{1 2}

On July 15, 2019, the Commission issued an Order declaring this proceeding a general rate case and suspending rates. On August 2, 2019, the Commission issued an Order scheduling hearings and requiring customer notice. Pursuant to that Order, the Public Staff and intervenors shall prefile testimony on or before November 4, 2019, and the Applicant shall prefile rebuttal testimony on or before November 19, 2019.

On November 18, 2019, CWSNC filed a motion requesting that the Commission approve an extension of time such that the Applicant be allowed to file testimony and exhibits on or before November 21, 2019, or within three business days after the Public Staff files its supplemental accounting testimony. In support of its request, CWSNC states that the Public Staff is in the process of developing its final position, anticipates filing supplemental accounting testimony and exhibits by November 18, 2019, and until that is done, CWSNC cannot determine with certainty the contested issues upon which it will file rebuttal testimony.

On November 18, 2019, Public Staff filed Revised Exhibits I and II of Public Staff witness Feasel and Revised Exhibit I of Public Staff witness Henry. The revised Exhibits reflected corrections to errors and updated expense information provided by CWSNC to the Public Staff. Public Staff did not file supplemental testimony.

Based upon the foregoing and the entire record herein, the Presiding Commissioner finds good cause to extend the deadline for filing rebuttal testimony to November 20, 2019.

IT IS, THEREFORE, SO ORDERED.
