## Dear Ms. Jarvis:

During the evidentiary hearing in this matter, Chairman Finley and Commissioner Clodfelter both questioned Aqua North Carolina, Inc. ("Aqua" or "Company") witness Shannon Becker about the 2002 contract reflecting agreement among Johnston County, Flowers Plantation and Heater Utilities for provision of bulk wastewater services.

- 1. Chairman Finley, in a question to Aqua State President Shannon Becker, referred to a "...2002 contract with the County and with Flowers Plantation and with Heater..." that was "...sort of a wholesale contract between Johnston County and Heater to give you capacity in the wastewater system of the County...." *Tr. Vol.* 16, page 36, line 24---page 37, line 4. The Chairman subsequently asked whether that contract was ever filed with the Commission for its approval. *Tr. Vol.* 16, p. 37, lines 11-13.
- 2. Commissioner Clodfelter then expressed the same interest in information about the status of the contract as a filed document and requested a definitive answer post-hearing about "...whether the Three-Party Agreement was filed with the Commission and, if so, in what context?" *Tr. Vol. 16*, p. 38, lines 2-8.

3. Finally, subsequent questioning of Aqua witness Becker by counsel elicited the response that at page 24 of his Rebuttal testimony, lines 9-12, he had stated that the 2002 contract in question had been filed with the Commission in Docket No. W-274, Sub 392. *Tr. Vol. 16, p. 108, lines 15-24 -- p. 109, lines 1-3.* 

In response to the Commissioners' questions, Aqua provides this link to Docket W-274 Sub 392, which contains Heater Utilities' 2002 Application for Certificate to Provide Sewer Service for Riverdell Elementary School in Johnston County. ("Application for Certificate.")
