P1. <u>DOCKET NO. W-218, SUB 491 – AQUA NORTH CAROLINA, INC. – REQUEST</u> FOR TARIFF REVISION

EXPLANATION: On March 28, 2018, Aqua North Carolina, Inc. (Aqua), filed a verified petition, pursuant to G.S. 62-133.11, with the Commission requesting authority to amend its tariff for the purpose of passing along to its water customers in Heather Glen, Highland on the Point, and Southpoint Landing Subdivisions in Gaston County the cost of purchasing water service from the City of Belmont (City).

Aqua owns and operates two community water well systems serving these subdivisions located within the one-half mile compliance buffer at the Allen Steam Station. North Carolina Session Law 2016-95 (House Bill 630 or CAMA) requires Duke Energy to establish permanent replacement water supplies for certain households, generally those that have a drinking water supply well located within a one-half mile radius from the boundaries of coal combustion residuals impoundments in North Carolina. Pursuant to CAMA, Duke Energy has recommended and the North Carolina Department of Environmental Quality (NCDEQ) has approved that the Aqua distribution system be interconnected to the City's water main and the City supplied water replace Aqua's existing wells as the sole supply to these subdivisions.

The City, by its own ordinances and the water purchase contract between Aqua and City, will charge Aqua according to its Outside City Limits rate schedule, which has increasing and then decreasing tiered block rates. Based on actual customer usage and well pumping data for the 12-month period ending in January 2018, the average rate charged by the City to Aqua is \$14.38 per 1,000 gallons.

Aqua's current uniform rates have been in effect since May 2, 2014, when they were approved by the Commission in its Order Approving Partial Rate Increase issued in Docket No. W-218, Sub 363. After taking into account the effect of the 0.14% regulatory fee, Aqua has requested authority to increase its water usage rates from \$5.43 to \$14.40

per 1,000 gallons to reflect the increase in the cost of purchasing water service from the City instead of pumping and treating water from its wells.

Under the new rates, the average residential customer's monthly water bill will increase by \$46.99 or 99.5%, from \$47.22 to \$94.21 based upon 5,000 gallons usage. The average monthly water bill includes the current Water System Improvement Charge (WSIC) of 4.77%, effective January 1, 2018, which was approved by the Commission in its Order Approving Water and Sewer System Improvement Charges on a Provisional Basis.

Duke Energy is offering eligible property owners the opportunity to participate in a Property Value Protection Plan and/or the Financial Supplement Program, which includes a voluntary financial supplement and water bill stipend. For the property owners that are Aqua customers in the Heather Glen, Highland on the Point, and Southpoint Landing Subdivisions, the voluntary financial supplement is \$5,000 per customer and the water bill stipend is \$14,097. The water bill stipend is equal to the difference between an average monthly 5,000 gallon usage water bill under Aqua's proposed purchased water rate and the current Aqua uniform rate for a period of twenty-five years. Duke Energy would make these payments up front, upon execution of a release and completion of all enrollment conditions by the customers and Commission approval of the applicable Aqua rates.

The Public Staff has reviewed Aqua's petition and recommends that the requested tariff revision be approved. The Public Staff is of the opinion that the tariff revision will allow Aqua to recover additional revenues that do not exceed the additional expenses.

ORDER APPROVING TARIFF REVISION AND **REQUIRING CUSTOMER** NOTICE

BY THE COMMISSION: On March 28, 2018, Aqua North Carolina, Inc. (Aqua), filed a verified petition, pursuant to G.S. 62-133.11, with the Commission requesting authority to amend its tariff for the purpose of passing along to its water customers in Heather Glen, Highland on the Point, and Southpoint Landing Subdivisions in Gaston County an increase in the cost of purchasing water service from the City of Belmont (City).

Aqua owns and operates two community water well systems serving these subdivisions located within the one-half mile compliance buffer at the Allen Steam Station. North Carolina Session Law 2016-95 (House Bill 630 or CAMA) requires Duke Energy to establish permanent replacement water supplies for certain households, generally those that have a drinking water supply well located within a one-half mile radius from the boundaries of coal combustion residuals impoundments in North Carolina. Pursuant to CAMA, Duke Energy has recommended and the North Carolina Department of Environmental Quality (NCDEQ) has approved that the Aqua distribution system be interconnected to the City's water main and the City supplied water replace Aqua's existing wells as the sole supply to these subdivisions.

The City, by its own ordinances and the water purchase contract between Aqua and City, will charge Aqua according to its Outside City Limits rate schedule, which has increasing and then decreasing tiered block rates. Based on actual customer usage and well pumping data for the 12-month period ending in January 2018, the average rate charged by the City to Agua is \$14.38 per 1,000 gallons.

This matter was presented at the Commission's Regular Staff Conference on April 23, 2018. The Public Staff stated that it had reviewed Aqua's petition and recommends that the requested tariff revision be approved. The Public Staff is of the opinion that the tariff revision will allow Aqua to recover additional revenues that do not exceed the additional expenses.

Based upon the foregoing, the Commission finds that Aqua should be allowed to pass through the costs associated with the purchased water expense.

1. That Aqua North Carolina, Inc., is granted a revision to Appendix A-2 of its tariff for water utility service in Heather Glen, Highland on the Point, and Southpoint Landing Subdivisions in Gaston County in which it purchases and resells water from the City of Belmont, as set forth herein.

2. That the revised Appendix A-2 attached hereto is approved and is deemed filed with the Commission pursuant to G.S. 62-138. This Schedule of Rates shall become effective for service rendered on and after the date the interconnection is completed and water is solely supplied by the City and that Aqua submit to the Commission a notarized letter certifying the interconnection completion and date of completion.

3. That the Notice to Customers, attached hereto as Appendix B, be mailed with sufficient postage or hand delivered by Aqua to all of its affected customers in the Heather Glen, Highland on the Point, and Southpoint Landing Subdivisions contemporaneously with the next billing of customers; and that Aqua submit to the Commission the attached Certificate of Service, properly signed and notarized, no later than 10 days after the date of the next billing.
